ORDINANCE NO. 534

AN ORDINANCE ANNEXING TO THE CITY OF ANOKA CERTAIN LAND SITUATED IN LOT EIGHT (8), AUDITOR'S SUBDIVISION NO. 32, SECTION 36, TOWNSHIP 32, RANGE 25, ANOKA COUNTY, MINNESOTA, WHICH LAND IS COMPLETELY SURROUNDED BY LAND WITHIN THE LIMITS OF THE CITY OF ANOKA.

The Commission of the City of Anoka does ordain as follows:

Section 1. The land hereinafter described is located in Ramsey Township and is completely surrounded by land within the limits of the City of Anoka. Said land is described as follows:

That part of Lot Eight (8), Auditor's Subdivision No. 32, Anoka County, Minnesota, described as follows:

Beginning at the Southwest (SW) corner of said Lot 8; thence North on the West line thereof 485 feet; thence East and parallel with the South line of said Lot 8 a distance of 415 feet; thence South and parallel with the West line of said Lot 8 a distance of 485 feet to the South line of said Lot 8; thence West on the South line of said Lot 8 a distance of 415 feet to the place of beginning, except the South 30 feet of said land described.

Section 2. Said land constitutes approximately 4.34 acres.

Section 3. The Commission of the City of Anoka hereby determines that the land described in Section 1 is completely surrounded by land within the limits of the City of Anoka and is hereby annexed, added to and made a part of the City of Anoka, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This Ordinance repeals Ordinance No. 527 of the City of Anoka, which latter ordinance incorrectly described the land intended thereby to be annexed to said City of Anoka.

Section 5. This Ordinance shall be in force and effect thirty (30) days from the date of publication and after the filing of a certified copy hereof with the Municipal Commission of the State of Minnesota, the Anoka County Auditor, and the Secretary of State of the State of Minnesota.

ORDINANCE NO. 527

AN ORDINANCE ANNEXING TO THE CITY OF ANOKA CERTAIN LAND SITUATED IN LOT EIGHT (8), AUDITOR'S SUBDIVISION NO. 32, SECTION 36, TOWNSHIP 32, RANGE 25, ANOKA COUNTY, MINNESOTA, WHICH LAND IS COMPLETELY SURROUNDED BY LAND WITHIN THE LIMITS OF THE CITY OF ANOKA.

The Commission of the City of Anoka do ordain as follows:

Section 1. The land hereinafter described is located in Ramsey Township and is completely surrounded by land within the limits of the City of Anoka. Said land is described as follows:

All of Lot Eight (8), Auditor's Sub-division No. 32, Anoka County, Minnesota, save and except the following portion of said Lot Eight (8), described as follows:

Commencing at the Southwest (SW) corner of said Lot Eight (8), thence North on the West line thereof Four Hundred Eighty-five (485') feet, thence East and parallel with the South line of said Lot Eight (8), a distance of Four Hundred Fifteen feet (415') thence South and parallel with the West line of said Lot Eight (8) a distance of Four Hundred Eighty-five feet (485') to the South line of said Lot Eight (8), thence West on the South line of said Lot Eight (8), a distance of Four Hundred Fifteen feet (415') to the place of beginning, save and except also the South Thirty feet (S 30') of the portion of Lot Eight (8) not included in the foregoing exception.

Section 2. Said land constitutes approximately 4.34 acres.

Section 3. The Commission of the City of Anoka hereby determines that the land described in Section 1 is completely surrounded by land within the limits of the City of Anoka and is hereby annexed, added to and made a part of the City of Anoka, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This Ordinance shall be in force and effect thirty (30) days from the date of publication and after the filing of a certified copy hereof with the Municipal Commission of the State of Minnesota, the Anoka County Auditor, and the Secretary of State of the State of Minnesota.
