AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO BE ANNEXED TO THE CITY OF NORTH MANKATO AND PROVIDING ZONING THEREFOR.

The Common Council of the City of North Mankato, Minnesota, does ordain as follows:

Sec. 1. All of the Plat of Mankato Area Vocational-Technical Institute Addition to the City of North Mankato, Nicollet County, Minnesota, including the portion thereof described as Lot 1, Block 1, and also including the portion thereof designated as "James Drive" and the portion thereof designated as "U.S. Highway No. 14", the same constituting 5.83 acres, more or less, and any and all streets, highways or other public rights of way within and adjacent to said described land, is hereby annexed and declared to be a part of the City of North Mankato and to be included in the corporate limits thereof.

Sec. 2. The above-described land be and hereby is zoned R-A pursuant to the Zoning Ordinance of the City of North Mankato, Minnesota.

Sec. 3. This Ordinance shall take effect from and after its date of passage and publication.
