Member Cox introduced the following resolution and moved its adoption: RESOLUTION TO CHANGE THE TIME OF THE CITY ELECTION FROM THE FIRST TUESDAY AFTER THE FIRST MONDAY IN DECEMBER TO THE FIRST TUESDAY AFTER THE FIRST MONDAY IN NOVEMBER.

BE IT RESOLVED, by the City Council of the City of Becker, Minnesota, that the City of Becker, Minnesota, will adopt the following ordinance:

ANNUAL CITY ELECTION CHANGE


THE CITY COUNCIL OF BECKER ORDAINS:

Pursuant to Minnesota Statute Section 205.07, the City Council

of the City of Becker, Minnesota, shall hold its regular City Election biennially on the first Tuesday after the first Monday in November, effective for the 1974 election and continuing thereafter. Whenever this change in the election year results in the expiration of any current term of office at a time when no city election is held in the months immediately prior thereto, each term is extended until the date for taking office following the next scheduled city election. The City Clerk is hereby directed to notify, in writing, the County Auditor and the Secretary of State of the change of the date of election.

The motion was seconded by Councilman Stumvoll and unanimously adopted by the Council.




