

ORDINANCE NO. A-74-111

AN ORDINANCE TO AMEND AN ORDINANCE KNOWN  
AS CHAPTER 13, UNCODED ORDINANCES IN EFFECT,  
OF THE CITY CODE OF THE CITY OF MANKATO,  
MINNESOTA

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City, does not exceed 200 acres, and is deemed to be urban in character;

THE CITY OF MANKATO, MINNESOTA DOES ORDAIN:

1. That the annexation will be to the best interest of the City and of the land affected;
2. That the land described herein abuts upon the City limits and is urban in character; and
3. That none of said land is now included within the limits of any city, village, or borough;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Mankato, that the corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been part thereof:

The South 791.2 feet of the East 396 feet of the W $\frac{1}{2}$  of the NW $\frac{1}{4}$  of the SW $\frac{1}{4}$  and the W $\frac{1}{2}$  fo the E $\frac{1}{2}$  of the NW $\frac{1}{4}$  of the SW $\frac{1}{4}$ , except therefrom the south 283 feet of the east 168 feet, all located in Section 16, T108N, R26W, comprising 12.11 acres.

The City Clerk is hereby directed to file certified copies of the Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

This Ordinance shall take effect thirty (30) days after the date of its passage and due publication and filing thereof.
