ORDINANCE NO. 1749

AN ORDINANCE ANNEXING to the City of Rochester, Minnesota, Certain Platted Land Situated in North Sunny Slopes, Olimsted County, Minnesota, THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:
Section 1. The City of Rochester, Minnesota, is owner of the land hereinafter described located in Rochester Township, Olmsted County, Minnesota, and which abuts upon the present terriforial limits of the City of Rochester;
Lot 44A, North Sunny Slopes, including the easterly half of the road adjacent thereto, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said County, Section 2. The quantity of land described in Section 1 is approximately 1,09 acres in area.

Section 3. The Common Council of the City of Rochester hereby determined that the land described in Section 1 abuts the present terriforial limits of the City of Rochester and is hereby annexed, added to and made a part of the City of Rochester Minnesola. As effectually as if it had originally been a part hereof.
