CITY OF CYRUS -- ORDINANCE NO. 45

An ordinance annexing a part of the Northeast Quarter of the Southeast Quarter (N. E. 1/4 S. E. 1/4) of Section Nineteen (19), Township One Hundred twenty-five (125), Range Forty (40) of New Prairie Township, County of Pope, State of Minnesota, to the City of Cyrus, Minnesota.

The City of Cyrus does ordain:

Section 1--There is hereby annexed to the City of Cyrus, Minnesota, the following described premises:

All that part of the Northeast Quarter of the Southeast Quarter (NE 1/4, SE 1/4) of Section Nineteen (19), Township One Hundred Twenty-five (125), Range Forty (40), which is described and enclosed within the following boundary lines to-wit:

Beginning at a point on the West line of the said Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4), Section Nineteen (19), 752.0 feet north of a point where an extension west of the north line of the alley as shown on the plat of Danielson's Addition as the same is on file and of record in the office of the Register of Deeds, Pope County, Minnesota, intersects the West line of the said Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4), Section Nineteen (19); thence East parallel with the North line of the said alley to the centerline of C. S. A. H. No. 3 as the same is laid out and maintained and of record; thence Southwesterly along the centerline of said C. S. A. H. No. 3 to the South line of said Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4), Section Nineteen (19); thence West along the South line of said Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4) Section Nineteen (19); to the West line of the said Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4), Section Nineteen (19); thence North along the West line of the said Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4), Section Nineteen (19), to the point of beginning; the above described tract of land contains 9.6 acres more or less excluding the existing Highway Right of Way.
