## ORDINANCE NO.35

AN ORDINANCE ANNEXING CERTAIN LOTS AND BLOCKS TO THE VILLAGE OF FOLEY IN THE COUNTY OF BENTON AND STATE OF MINN.

The Common Council of the Village of Foley in the County of Benton and State of Minnesota, do ordain as follows:

SECTION 1.- That the following described pieces or parcels of land, to-wit:

Lots one (1), two (2), three (3), four (4), five (5), six (6), seven (7), and eight (8), Park Lots Addition to the Village of Foley described by metes and bounds as follows:

Beginning at the Southeast corner of Park Lots Addition to the Village of Foley; thence North sixty degrees twenty minutes East and parallel with the North line of the Great Northern right of way 970.65 feet to a point; thence North and parallel with the East line of said Park Lots Addition 292.9 feet to a point; thence South sixty degrees thirty minutes west a distance of 1022.6 feet to a point on the East line of said Park Lots Addition, the said point being the Southeast corner of Lot nine (9) in said Park Lots Addition; thence South on the East line of said Park Lots Addition 308.12 feet to the point of beginning, all in Section 25, Township 37, Range 29.
