## CEDINANCE NO. 54

AN OPDINANCE EXEMPING THE CORPORATE LIMITS OF THE VILLAGE OF AVON, STEARNS COUNTY, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND, NOT EXCEEDING THIRTYSONE AND SEVENTE-FOUR HUNDREDTHS ACRES IN AREA.

SECTION 1. A Petition has been filed with the governing body of the Village of Avon, Minnecota, by the sole owner of the following described real estate, to have such land included within the Village of Avon, Minnesota;

Lots Five (5) and Six (6) of Section Twenty-eight (28), Township One Hundred Twenty-five (125) North, Range Thirty (30) West, excepting all that part thereof described as follows: Beginning at the Southeast Corner of the Southwest Guarter (SNE) of Section 28, in Township 125, Range 30; theme West 10.70 Chains to the Center of a Public Road; thence North 31 Degrees 45 minutes East 4.10 chains along the Center of the Road; thence East 13.40 chains to the lake; thence South 39 degrees, 15 minutes West, 4.52 chains to the point of beginning;

Excepting also beginning at a point in the Center of a Road 977 feet West of the Northeast Corner of the Southwest Quarter of the Southeast Cuarter (SNA, SEA) of Section 28, Township 125, Range 30; thence South 44 Degrees West along the Road 254 feet; thence North 72 Degrees 14 Minutes West, 406,5 Feet to the Lake Shore; thence South 35 Degrees 14 Kirutes West, 110 Feet; themse South 73 Degrees 28 Minutes East 1652 Feet; thence North on the 1/16th Section Line 620.79 Feet; thence West 977 Feet to the place of beginning;

Also excepting, all that pardel of land situated in Section 28, 125, Range 30, bounded and described as follows: Beginning at an Iron Stake, marking the Northwest Corner of Lot Five (5) of said Section 28} thence due East 258 Feet to the Stake in middle of Avon and Cold Spring Road; thence South 43 Degrees 55 Minutes West along the middle of said Road 254 Feet to an Iron Pin; thence North 72 Degrees 14 Minutes West 406.3 Feet to an Iron Pin on the Lake Shore; thence North 33 Degrees 10 Minutes East 485.4 Feet along the Lake Shore to a Stake; thence due South 317.5 Feet to the place of beginning.

Lot Seven (7) of Section Twenty-eight (28), Township One Hundrid

Twenty-five (125) North, Range Thirty (30) West:

And, Lot Five (5), less that part platted as Sunny Side of Section Twentynine (29), all in Township One Hundred Twenty-five (125), North of Range Thirty (30) West; ALSO LESS and except lands from Frank A. Fischer and Wife to Earl Sadlouski and wife, as recorded in Book 295 of Deeds on Page 512. being part of Government Lot Five (5) of Section 29, Township 125, Range 30; ALSO LESS and except lands from Frank A. Fischer and wife, to Thomas Vos and wife, being a part of Government Lot Bix (6), of Section 28, Township 125, Hange 30, as recorded in Book 290 of Deeds on Page 114; ALSO LESS and except parts of government lots Five (5) and Six (6) of Section 28, Township 125 Range 30, as deeded from Frank R. Fischer and wife, to John Fischer, and recorded in Book 312 of Deeds on Page 324; ALSO LESS and except a part of Government Lot Six (6) of Section 28, Township 125, Range 30, as deeded from Frank A. Fischer and wife, to Joseph Harold Fischer and recorded in Book 312 of Deeds on page 325; ALSO LESS and except a part of Government Lot Five (5) of Section 28, Township 125, Range 30, as deeded from Frank A. Fischer and wife, to Warren Fischer and recorded in Book 312 of Deeds on page 350; ALSO LESS and except part of Government Lots Five (5) and Six (6) of Section 28, Township 125, Range 30, as deeded from Frank A. Fischer and wife, to Paul Rischer, and recorded in Book 312 of Deeds on page 351.

EXCEPTING HOWEVER, from the above-described tracts, those parts or portions thereof, already lying and being within the Corporate limits of

the Village of Avon, Steams County, Minnesota.

SECTION 2: The quantity of land cabraced within the foregoing description and bounded as described is, Thirty-One and Seventy-Four Hundredths Acres.

SECTION 3: The Village Council hereby determines that the annexation will be to the best interests of the Village of Avon, Minnesota, and of the territory affected; that the territory described herein, abuts upon the Village and is so conditioned as properly to be subject to Village government.

SECTION 4: The Corporate limits of the Village are hereby extended to include the property described in Section One, and the same is hereby annexed to and included in the Village, as effectually as if it had originally been a part thoroof.

SECTION 5: The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor for Stearns County, Minnocota and the Secretary of State.

SECTION 6: This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directioned in Section 5.
