

Ordinance No. 74-4

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LINDSTROM TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deemed to be urban in character;

The City Council of Lindstrom ordains:

Section 1. Territory Annexed. The corporate limits of the City of Lindstrom, Minnesota, are hereby extended to include the platted and unplatted territory described as follows, which territory now is and has heretofore been completely surrounded (60% or more of the perimeter of which territory is bordered) by territory already included within the city limits:

All of the Northeast Quarter of the Northeast Quarter of Section thirty-three (NE $\frac{1}{4}$ -NE $\frac{1}{4}$, Sec. 33) in Township 34 North, Range 20 West, Chicago County, Minnesota,

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.

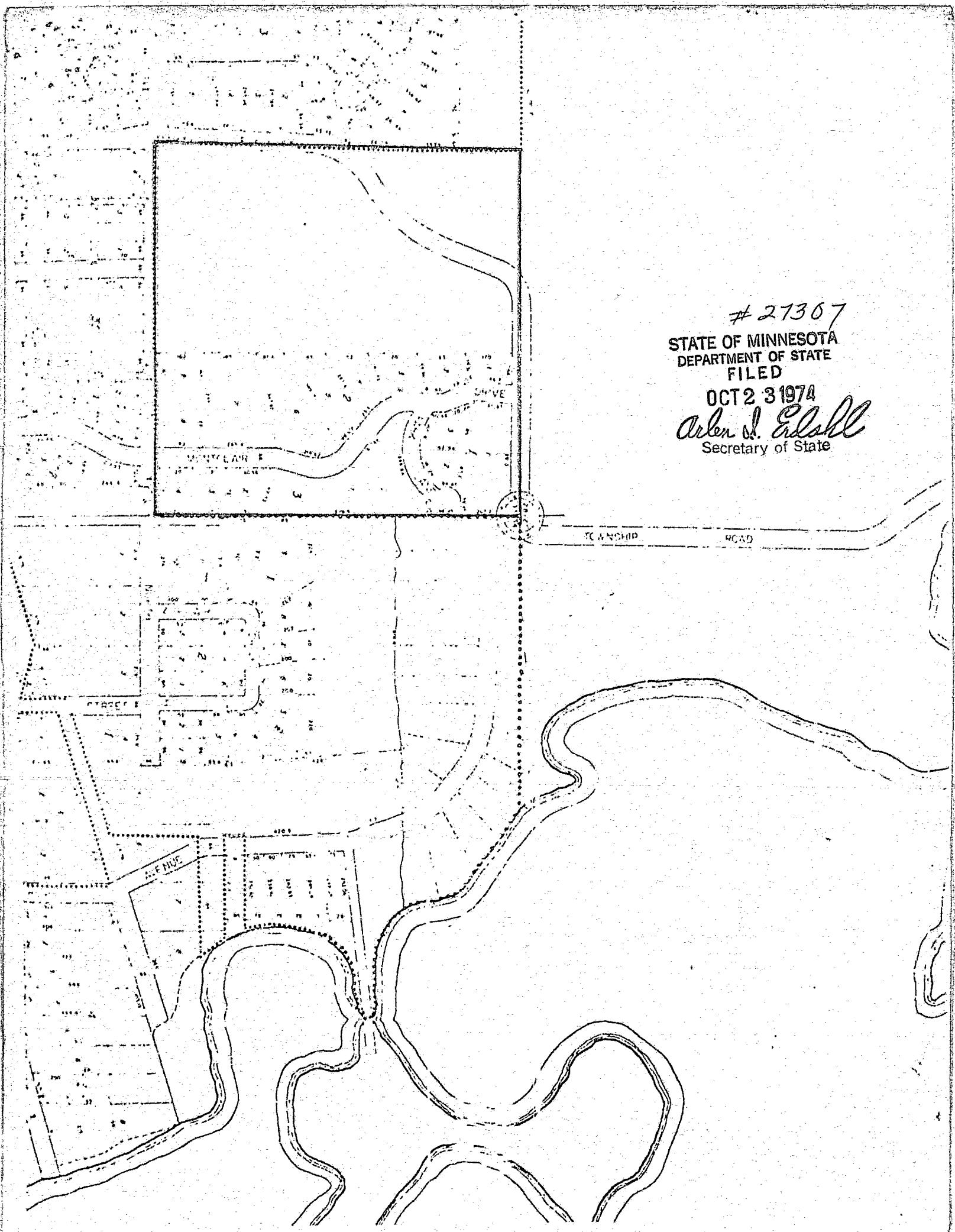
