Ordinance No. 74-5

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LINDSTROM TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated October 15, 1973, requesting annexation of the territory hereinafter described was duly presented to the Council on the 11th day of April, 1974; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 19.07 acres of unplatted land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the southern boundary thereof;

The Council of the City of Lindstrom, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

A tract of land lying in Section Thirty-Three (33), Township Thirty-four (34), Range Twenty (20), the East 264 feet, or 16 rods, of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$  of SE $\frac{1}{4}$ ), comprising 8 acres.

A tract of land lying in Section Thirty-four (34), Township Thirty-four (34), Range Twenty (20) - a part of Government Lot Ten (10) as follows: Beginning at the northwest corner of said Government Lot 10; thence south along the west line thereof for 1320 feet to the Southwest corner of said Lot 10; thence East, along the South line of Lot 10, for 305 feet; thence North 28° 33' East for 22.77 feet; thence North 6° 34' East for 519 feet; thence North 1° 6' West for 782.66 feet to the North line of said Government Lot 10; thence West, along said North line, for 375 feet to the point of beginning, and comprising 11.07 acres of land. Together with the public roadway 50 feet in width abutting said property on the East side thereof.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

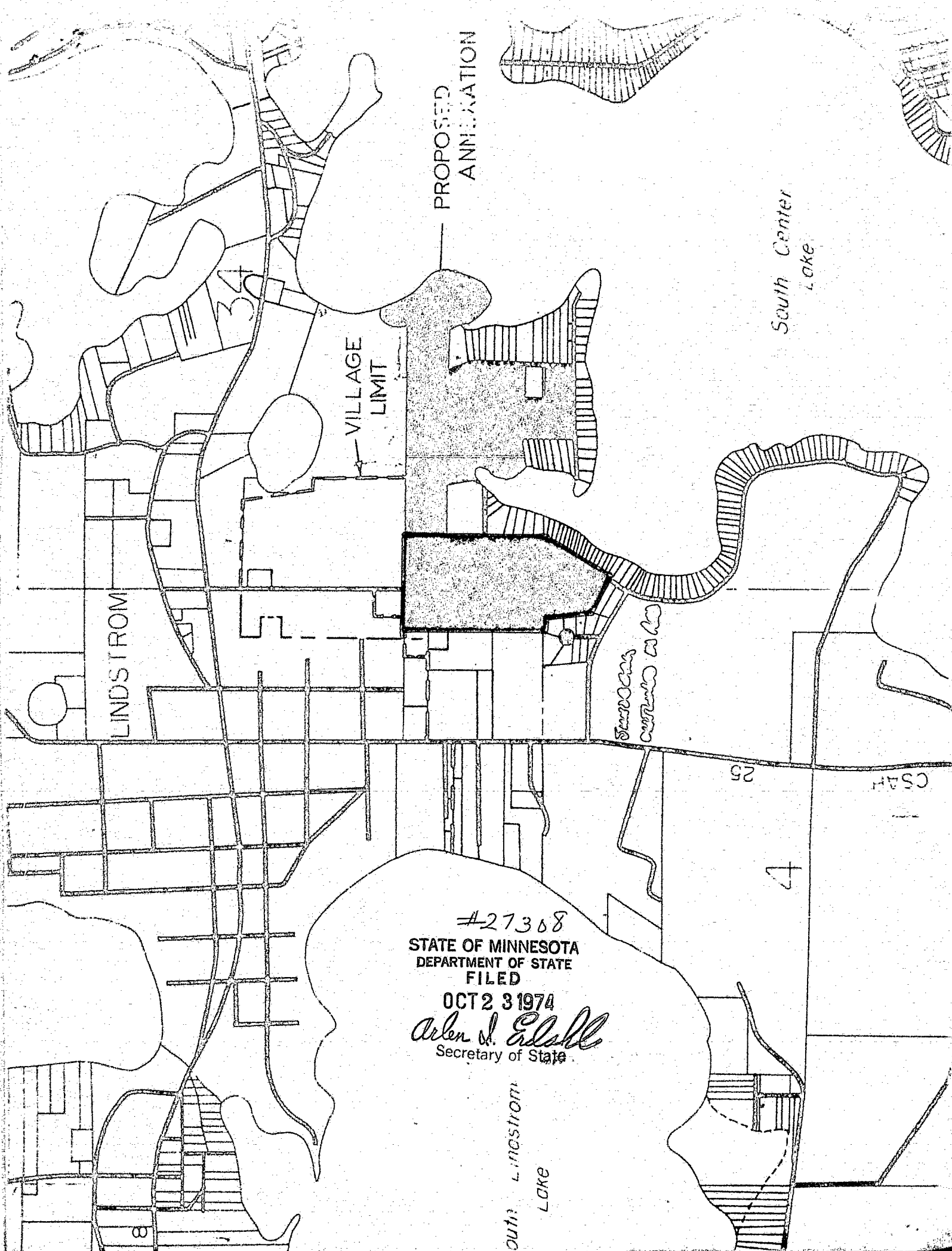
