

ORDINANCE NUMBER 1974-3

AN ORDINANCE EXTENDING THE CORPORATE CITY LIMITS OF THE CITY OF ALBANY, STEARNS COUNTY, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LANDS, NOT EXCEEDING 200 ACRES IN AREA, ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain ^{/petition} requesting annexation of the territory hereinafter described was duly presented to the Council on the 17th day of December, 1973, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than 200 acres of unplatted land, no part of which is included within the limits of an incorporated city, and

WHEREAS, the petition was signed in behalf of two owners, consisting of all of the two owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or other governing ~~and~~ body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and

WHEREAS, due notice of the petition for annexation was forwarded to the Town Board and the County Board at least 30 days prior to the ordinance to annex, and

WHEREAS, the land described in the petition abuts upon the City limits on the Easterly and Southerly boundaries thereof;

The Council of the City of Albany, Stearns County, Minnesota ordains:

Section 1. The City Council hereby determines

- (a). that the annexation will be to the best interest of the City and of the territory affected;
- (b). that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and
- (c). that none of said territory is now included within the of any city.

Section 2. Territory Annexed. The corporate limits of the City of Albany are hereby extended to include the unplatted lands described as follows and the same is hereby annexed to and included within the City as effectually as if it had been originally a part thereof:

That part of the Westerly Five Hundred Seventy Nine and Four Tenths (579.4) feet of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Fifteen (15), Township One Hundred Twenty Five (125) North, of Range Thirty One (31) West, lying Southerly of the centerline of Old Trunk Highway No. 52, and that part of the Westerly Five Hundred Seventy Nine and Four Tenths (579.4) feet of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Twenty Two (22), Township One Hundred Twenty Five (125) North, of Range Thirty One (31) West, lying Northerly of a line parallel to and Fifty Two (52) feet Northerly of the centerline of the main line railroad track of Burlington Northern, Inc.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.


