## RESOLUTION ADOPTING AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WATKINS TO INCLUDE UNPLATTED LANDS ABUTTING UPON THE CITY LIMITS

BE IT RESOLVED by the City Council of the City of Watkins, Minnesota, the following ordinance is hereby adopted as Ordinance No. <u>1 B</u>, the Mayor and Clerk are hereby authorized to sign the same, and the Clerk is directed to make arrangements for publication of the same in The Patriot, to-wit:

## ORDINANCE NO. 1B

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WATKINS TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition, dated June 5, 1974, requesting annexation of the territory hereinafter described was duly presented to the council on the 5th day of June, 1974, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 2.02 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all the owners of said land; and

WHEREAS, no objections to the annexation have been received from the town board of Forest Prairie Township, the Meeker County Board of Commissioners, or the Minnesota Municipal Commission, said bodies having due notice as provided by statute, and more than sixty (60) days having elapsed since such notice was provided; and

WHEREAS, the land described in the petition abuts the city limits at the West boundary thereof;

NOW THEREFORE, THE COUNCIL OF THE CITY OF WATKINS, MINNESOTA, ORDAINS:

<u>Section 1.</u> The city council hereby determines (1) that the annexation will be in the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough. <u>Section 2. Territory Annexed.</u> The corporate limits of the city are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

All that part of the Northeast Quarter of the Southwest Quarter (NE 1/4 SW 1/4) of Section Two (2), Township One Hundred Twenty-one (121) North, Range Thirty (30) West, Meeker County, Minnesota, described. as follows: Beginning at a point on the North and South Quarter Section Line of Section 2, Township 121 North, Range 30 West, and 1291.25 feet South of the center of said Section 2; thence deflect right 90°00' in Westerly direction 160.0 feet; thence deflect right 90°00' in a Northerly direction, a distance of 550.0 feet; thence deflect right 90°00' in an Easterly direction 160.0 feet to North and South Quarter Section Line; thence South along said North and South Quarter Section Line a distance of 550.0 feet to point of beginning, said tract containing 2.02 acres.

<u>Section 3.</u> Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Meeker County Auditor, and the Clerk of the Township of Forest Prairie.

<u>Section 4.</u> Effective Date. This ordinance takes effect upon its passage, publication, and the filing of the certified copies as directed in Section 3.
