



RESOLUTION

WHEREAS, Minnesota Statutes Chapter 487 authorize the County Board to increase the number of judges of the County Court, and;

WHEREAS, the County Court judges have requested authorization for an additional County Court judge position, and;

WHEREAS, the Board of Anoka County Commissioners finds that the existing caseload, particularly in the area of family, juvenile and jury cases, now exceeds the present capacity of four judges to efficiently and effectively bring all matters to a speedy and proper disposition;

NOW, THEREFORE, BE IT RESOLVED of the Anoka County Board of Commissioners:

1. That the number of County Court Judges in and for the County of Anoka is hereby set at five (5), which is an increase of one (1) above the previous number of four (4) judges of the County Court.
2. That any prior resolutions, recommendations, or actions of this board relating to setting the number of judges of the Anoka County Court are hereby rescinded.
3. That a certified copy of this Resolution be filed in the Office of Secretary of State, forthwith. #27315
