

NOW, THEREFORE, I, Wendell R. Anderson, Governor of the State of Minnesota, acting pursuant to the provisions of Minnesota Statutes 490.124, do hereby order and direct the retirement of the Honorable Vincent Hollaren, to become effective at the close of business on December 31, 1974. He shall become entitled thereafter to retirement compensation as provided under the law, and I further direct that this Order be filed in the Office of the Secretary of State of the State of Minnesota.

Dated this 18th day of November, 1974, at the State Capitol in the City of Saint Paul, Minnesota.


