MINNESOTA STATE JUNIOR COLLEGE BOARD

PARKING AND TRAFFIC REGULATIONS FOR INVER HILLS STATE JUNIOR COLLEGE AND PENALTY FOR THE VIOLATIONS THEREOF.

Be it ordained by the Minnesota State Junior College Board.

Section I - PARKING AND TRAFFIC RULES AND REGULATIONS ADOPTED.

The Minnesota State Junior College Board, pursuant to Minnesota Statute 169.66 and Minnesota Session Laws Chapter 966 Section 20 (1971), hereby adopts the following Parking Traffic Rules and Regulations to be administered and enforced on the property of Inver Hills State Junior College:

- 1. Only those vehicles belonging to students or employees of Inver Hills State
 Junior College or to other persons having a purpose or function at the college
 may park on college property.
- 2. Parking is prohibited on college property in the evening after 11:30 p.m. with the following exceptions:
 - a. Vehicles that are owned or leased by the College.
 - b. Vehicles belonging to those persons covered by the above regulation Number 1 who are in attendance at an activity which is not completed before 11:00 p.m. and which activity has the written approval of the college President.
 - 1. When approved activities are not completed until 11:00 p.m. or later, vehicles are to be removed from college property within 30 minutes after the completion of the activity.
 - c. Vehicles belonging to college employees whose hours of employment require their presence at the college between the hours of 11:00 p.m. and 7:00 a.m.
- 3. Parking is prohibited on college roadways, sidewalks, landscaped areas, safety zones, loading zones, within ten feet of intersections, adjacent to yellow curbs, and in areas where parking is expressly prohibited by signs. Exceptions to this regulation are as follows:
 - a. College-owned vehicles, when being used in the performance of work on college property.
 - b. Vehicles making delivery of goods to the college may park in the loading zones during required delivery time.
 - c. Vehicles are permitted to park adjacent to the east curb of the entrance driveway (right-hand curb when entering the college property) except where curb is yellow or restricted by a No Parking sign.
- 4. Parking in a restricted area shall be limited to those persons who have been issued a Special Permit for parking in a restricted area. Special Permits are issued by the Dean of Students in the form of a card or sticker which must be displayed when the vehicle is parked in the restricted area.

5. Parking lanes are designated by painted yellow lines. Adequate space has been provided between each set of yellow lines to park an automobile. Parking is

restricted to a maximum of one parking lane per vehicle. Parking on yellow lane lines or parking in a position which occupies more than one parking lane is prohibited.

- 6. All vehicles are required to follow directional arrows and signs to gain entrance to and exit from parking areas.
- 7. Maximum speed of vehicles on college property shall be 30 miles per hour, and such lesser speeds as may be indicated by posted signs.
- 8. The dumping or depositing of any refuse on college property is prohibited.
- 9. The regulatory provisions of Minnesota Statutes 1961 Chapter 169, as amended, are hereby adopted as traffic regulation controlling the use of parking facilities and private roads, roadways and college property on property owned, leased, occupied or operated by the Inver Hills State Junior College.
- 10. No person shall drive or operate a snowmobile on property owned, leased, occupied on operated by the Inver Hills State Junior College without the express written permission of the President of the college or his designate.

Section II - ENFORCEMENT

Every sheriff, constable, police officer, or other peace officer shall see that all rules of this regulation are obeyed and shall arrest and prosecute offenders.

Section III - PENALTIES

Any person violating any provision of this regulation shall be guilty of a petty misdemeanor. Any fines paid as a result of a violation of this ordinance shall be paid to the Village of Inver Grove Heights in the same manner as fines received from the violation of Village Ordinances.

Section IV - EFFECTIVE DATE

The regulation shall be in full force and effect from and after its adoption according to law.

ORDINANCE NO. 1

AN ORDINANCE PROVIDING PARKING AND TRAFFIC REGULATIONS FOR WORTHINGTON STATE JUNIOR COLLEGE AND IMPOSING A PENALTY FOR THE VIOLATIONS THEREOF.

Be it ordained by the State Junior College Board

Section I - Parking and traffic rules and regulations adopted.

The Minnesota State Junior College Board, pursuant to Minnesota Statute 169.66 and Minnesota Session Laws Chapter 966 Section 20 (1971), hereby adopts the following Parking Traffic Rules and Regulations to be administered and enforced on the property of Worthington State Junior College.

- 1. Only those vehicles belonging to students or employees of Worthington State Junior College or to other persons having a purpose or function at the college may park on college property.
- 2. Parking is prohibited on college roadways, sidewalks, landscaped areas, safety zones, loading zones, within ten feet of intersections, adjacent to yellow curbs, and in areas where parking is expressly prohibited by signs or in areas by other than those specifically designated for the classified and unclassified college personnel. Exceptions to this regulation are as follows:
 - a. College-owned vehicles, when being used in the performance of work on college property.
 - b. Vehicles making delivery of goods to the college may park in the loading zones during required delivery time.
- 7. Parking in a restricted area shall be limited to those persons who have been issued a Special Permit for parking in a restricted area. Special Permits are issued by the Dean of Students in the form of a card or sticker which must be displayed when the vehicle is parked in the restricted area.
- 4. Parking lanes are designated by painted yellow lines. Adequate space has been provided between each set of yellow lines to park an automobile. Parking is restricted to a maximum of one parking lane per vehicle. Parking on yellow lane lines or parking in a position which occupies more than one parking lane or blocks the exit or entrance of another vehicle is prohibited.

- 5. All vehicles are required to follow directional arrows, signs, and regular roadways to gain entrance to and exit from parking areas.
- 6. Maximum speed of vehicles on college property shall be 20 miles per hour, and such lesser speeds as may be indicated by posted signs.
- 7. The dumping or depositing of any refuse on college property is prohibited.
- 8. The regulatory provisions of Minnesota Statutes 1961 Chapter 169, as amended, are hereby adopted as traffic ordiance regulating the use of parking facilities and private roads, roadways and college property owned, leased, occupied or operated by the Worthington State Junior College.
- 9. No person shall drive or operate a snowmobile or any other vehicle other than as specified in this ordinance on property owned, leased, occupied, or operated by the Worthington State Junior College without the express written permission of the President of the college or his designate.

Section II - Enforcement

Every sheriff, constable, police officer, or other peace officer shall see that all rules and regulations of this ordinance are obeyed and shall arrest and prosecute offenders.

Section III - Penalties

Any person violating any provision of this ordinance shall be guilty of a misdemeanor. Any fines paid as a result of a violation of this ordinance shall be paid to the City of Worthington in the same manner as fines received from the violation of City of Worthington Ordinances.

Section IV - Effective Date

This ordinance shall be in full force and effect from and after its adoption according to law.

MINNESOTA STATE JUNIOR COLLEGE BOARD

PARKING AND TRAFFIC REGULATIONS FOR LAKEWOOD STATE JUNIOR COLLEGE AND PENALTY FOR THE VIOLATIONS THEREOF.

Be it ordained by the Minnesota State Junior College Board.

Section I - PARKING AND TRAFFIC RULES AND REGULATIONS ADOPTED.

The Minnesota State Junior College Board, pursuant to Minnesota Statute 169.966 and Minnesota Session Laws Chapter 966 Section 20 (1971), hereby adopts the following Parking Traffic Rules and Regulations to be administered and enforced on the property of Lakewood State Junior College:

- 1. The regulatory provisions of Minnesota Statutes 1961 Chapter 169, as amended, are hereby adopted as traffic regulation controlling the use of parking facilities and private roads, roadways and college property on property owned, leased, occupied or operated by Lakewood State Junior College.
- 2. All persons parking automobiles on property owned, leased, or occupied by Lakewood State Junior College will do so at their own risk. No responsibility will be assumed by the college or the state because of loss of property, damage to automobile while parked, damage which may be incurred through the process of impounding the automobile or for any other damage or loss sustained while on a junior college parking facility.
- 3. Only those vehicles belonging to students or employees of Lakewood State Junior College or authorized college visitors may park on college property.
- 4. Parking is prohibited on college property in the evening after 12:30 p.m. with the following exceptions:
 - a. Vehicles that are owned or leased by the College.
 - b. Vehicles belonging to those authorized persons who are in attendance at an approved activity which is not completed before 12:00 p.m. When approved activities are not completed until 12:00 p.m. or later, vehicles are to be removed from college property within 30 minutes after the completion of the activity.
 - c. Vehicles belonging to college employees whose hours of employment require their presence at the college between the hours of 12:00 p.m. and 7:00 a.m.

- 5. Parking is prohibited on college roadways, sidewalks, landscaped areas, safety zones, loading zones, within ten feet of intersections, adjacent to yellow curbs, and in areas where parking is expressly prohibited by signs. Exceptions to this regulation are as follows:
 - a. College-owned vehicles, when being used in the performance of work on college property.
 - b. Vehicles making delivery of goods to the college may park in the loading zones during required delivery time.
- 6. Parking in the restricted area shall be limited to those persons who have been issued a Special Permit for parking in a restricted area. Special Permits are issued by the college in the form of a card or sticker which must be displayed when the vehicle is parked in the restricted area.
- 7. Parking lanes are designated by painted yellow lines. Parking on yellow lane lines or parking in a position which occupies more than one parking lane is prohibited.
- 8. All vehicles are required to follow directional arrows and signs to gain entrance to and exit from parking areas.
- 9. Maximum speed of vehicles on college property shall be 15 miles per hour.
- 10. No person shall drive or operate a snowmobile on property owned, leased, occupied or operated by the Lakewood State Junior College without the express written permission of the President of the college or his designate.
- 11. Nothing in this policy shall prevent state, county, or local law enforcement agencies from enforcing traffic laws in effect in the jurisdictional area which the college is located. The laws are assumed to be common knowledge and must be obeyed.

Section II - ENFORCEMENT

All authorized law enforcement officers shall see that all rules of this regulation are obeyed and shall arrest and prosecute offenders.

Section III - PENALTIES

1. Any person violating any provision of this regulation shall be guilty of a petty misdemeanor. Any fines paid as a result of a violation of this ordinance shall be paid to the City of White Bear in the same manner as fines received from the violation of City Ordinances.

 The President may order any motor vehicle parked at the College in violation of these rules and regulations to be removed. The cost of such removal shall be borne by the owner or operator of the motor vehicle.

Section IV - EFFECTIVE DATE

The regulation shall be in full force and effect from and after its adoption according to law.
