REORGANIZATION ORDER NUMBER 42

Pursuant to Minnesota Statutes, Section 16.125, 16.13 and 16.135 the following administrative reorganization is hereby made.

These functions and personnel transfers relate to Executive Order No. 72 affecting the Department of Administration and the Department of Finance.

All management functions and responsibilities of the Minnesota Crime Information System, as related to the Department of Administration, Information Systems Division, are hereby transferred to the Department of Finance. The Minnesota Crime Information System hardware, software, for operations, and daily operational responsibilities remain in the Information Systems Division.

The authority to enter into agreements for Minnesota Crime Information System supportive services provided to the Bureau of Apprehension is hereby transferred from the Information Services Division to the Department of Finance. This includes authority for budgeting and expenditure of any funds for computerization related to the state-wide criminal justice system.

The following positions of the Department of Administration and their incumbents with all accrued benefits are hereby transferred to the Department of Finance.
