ORDINANCE NO. 97

AN ORDINANCE ANNEXING LANDS TO THE CITY OF GOODHUE

The City Council of Goodhue ordains that the land area contained within the following described boundaries is hereby annexed to and incorporated within the City of Goodhue, to-wit:

That part of the East Half (E $\frac{1}{2}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 20, Township 111 North, Range 15 West, Goodhue County, Minnesota, described as follows:

Beginning at the southeast corner of said Section 20; thence northerly along the east line of said Section 20 a distance of 811.14 feet (49.16 rods); thence westerly perpendicular to said east line, a distance of 863.78 feet (52.35 rods); thence southerly, parallel to said east line, a distance of 807.79 feet to the south line of said Section 20; thence easterly along said south line a distance of 863.80 feet to the point of beginning.

EXCEPT:

All that part of the Southeast Quarter (SE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 20, Township 111 North, Range 15 West, in Goodhue County and State of Minnesota, described as follows:

Beginning at the southeast corner of said Section 20; thence North along the East line of said Section 383.5 feet to an iron pipe in the center of Park Avenue; thence west 276 feet to an iron fence post; thence south 383.5 feet to the center of Highway No. 9. Said line passing through the center of large galvanized iron pipe culvert. Thence east along the center of said Highway 276 feet to the place of beginning.

ALSO EXCEPT that part lying southerly of a line 296.43 feet northerly of, measured at right angles to and parallel with the south line of said Section 20.
