An ordinance extending the Corporate limits of the City of

Northfield to include certain unincorporated unplatted land not exceeding

200 acres in area abutting upon the City limits.

WHEREAS, a certain petition dated June 24, 1974, requesting annexation of the territory hereinafter described was duly presented to the Council on the 24th day of September , 1974; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 19½ acres more or less of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all owners; and
WHEREAS, a part of this territory is owned in fee by the City; and
WHEREAS, no objections to the annexation have been received from
the town board, the county board, or the governing body of any
municipality whose boundaries abut upon the boundaries of the land
to be annexed; and

WHEREAS, the land described in the petition abuts upon the City limits at the Southerly boundary thereof; the Council of the City of Northfield, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and (3) that none of said territory is now included within the limites of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

20 West of the Fifth Principal Meridian, Rice County, Minnesota. Except that part described as beginning at a point on the East line of said North One-half (N½) distant 310 Feet South of the Northeast Corner of said North One-half (N½); thence Westerly at a right angle to said East line 175.00 Feet; thence Southerly, at a right angle, 130.00 Feet; thence Easterly, at a right angle, 175.00 Feet to the East line of said North One-half (N½); thence Northerly along said East line 130.00 Feet to the point of beginning.

Subject to Minnesota Trunk Highway No. 246 over and across the Easterly side thereof.

Subject to an easement running in favor of Northwestern Bell Telephone Company, as recorded in the Office of the Register of Deeds, Rice County, Minnesota, in Book 33 of Miscellaneous Records, pages 249-250.

Section 3. Filing. The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
