REORGANIZATION  
COMMISSIONER'S ORDER  
NO. 30

November 19, 1974

WHEREAS, The Commissioner of Public Safety of the State of Minnesota is empowered to designate a director of the division of Driver's License of the Department of Public Safety by the provisions of Minn. Stat. (1969) §171.015, subdivision 1; and,

WHEREAS, The Commissioner of Public Safety of the State of Minnesota is empowered to designate a director of the division of Motor Vehicles of the Department of Public Safety by the provisions of Minn. Stat. (1969) §168.325, subdivision 1; and,


WHEREAS, The Commissioner of Public Safety is empowered by the provisions of Minn. Stat. (1969) §299A.01, subdivision 3, to organize the Department of Public Safety in a manner which he deems necessary to carry out the functions of the Department as required by law; and assign individuals employed therein with such duties, powers, and responsibilities to carry out such functions; and,

WHEREAS, The Commissioner of Public Safety has determined it is in the best interests of the State of Minnesota that the Department of Public Safety be reorganized to separate the Division of Motor Vehicle Services into two separate divisions of Driver's License and Motor Vehicles; and create positions in the unclassified service of Driver's License Director and Motor Vehicles Director;




THEREFORE, I, Edward G. Novak, duly appointed Commissioner of Public Safety of the State of Minnesota, do hereby separate the Division of Motor Vehicle Services into two separate divisions of Driver's License and Motor Vehicles. Further, these divisions are to be under the supervision and control of the Director of Driver's License and the Director of Motor Vehicles, respectively, and are to be appointed by me and serve in the unclassified service of the State of Minnesota at my pleasure. The position of Director of Motor Vehicle Services is abolished; and all authority, powers, duties, and responsibilities delegated therefore to the holder of this position shall continue within the framework of the separate divisions of Driver's License and Motor Vehicles.

The separation of this division and the appointments of the Director of Driver's License and the Director of Motor Vehicles, and the delegation of the authority, powers, duties, and responsibilities that such Directors will hold shall be effective December 16, 1974.
