

ORDINANCE 74-5
AN ORDINANCE CONCERNING ANNEXATION

THE CITY OF GRANITE FALLS DO ORDAIN AS FOLLOWS:

That the Reverence for Life and Concern for People, Inc. and Elmer O. Aakre and Zula D. Aakre, the sole owners of the property described in this Ordinance, have petitioned the City of Granite Falls for Annexation of the following described property to the City of Granite Falls.

That the following described land is unplatted, does not exceed 200 acres, that more than 60 days have past since filing of the Petition of Annexation, and that no objections have been received.

The City Council of the City of Granite Falls having determined that the Annexation will be to the best interest of the Municipality and of the territory affected, the following described land situated in the County of Yellow Medicine, State of Minnesota, is hereby declared annexed to the City of Granite Falls:

All that part of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ of NE $\frac{1}{4}$) and the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Thirty-Two (32), Township One Hundred Sixteen (116), Range Thirty-Nine (39) described as follows to-wit: Beginning at the Northwest Corner of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Thirty-Three (33), Township One Hundred Sixteen (116), Range Thirty-Nine (39), thence West Three Hundred Ninety One and Twenty Four One Hundredths (391.24) feet to the point of beginning, thence North Three Hundred Fifty One (351) feet, thence West Seven Hundred (700) feet, thence South Six Hundred (600) feet, thence East Seven Hundred (700) feet; thence North Two Hundred Forty Nine (249) feet to the point of beginning, containing approximately Nine and Sixty Four One Hundredths (9.64) acres more or less. And in addition incorporating the following described tract of land beginning at the Northwest Corner of the Northwest Quarter of the Southwest Quarter of Section Thirty-Three (33), Township One Hundred Sixteen (116), Range Thirty-Nine (39), thence West Three Hundred Ninety One and Twenty Four One Hundredths (391.24) feet to the point of beginning, thence North Eighty One (81) feet, thence East Thirty (30) feet, thence South along the presently existing West boundary line of the City of Granite Falls Three Hundred and Thirty (330) feet, thence West Thirty (30) feet, thence North Two Hundred Forty Nine (249) feet to point of beginning, said real estate incorporating all land between the above described plot of land and the presently existing city limits of Granite Falls, namely an alley or roadway 30 feet in width and 330 feet in length.
