

ORDINANCE NO. 147

AN ORDINANCE PROVIDING FOR ANNEXATION OF CERTAIN LAND ABUTTING THE VILLAGE UPON PETITION OF ALL OF THE OWNERS OF SUCH LAND

THE VILLAGE COUNCIL OF DELANO, MINNESOTA, ORDAINS:

Section 1. That pursuant to a petition by all of the owners of certain property comprising less than two hundred (200) acres, legally described as follows:


West Half of the Northeast Quarter; South Half of the Southeast Quarter of Northeast Quarter; and East Half of the Southeast Quarter North of railroad, all in Section 12, Township 118, Range 25, except the South 275 feet of the East 198 feet of the West Half of Southwest Quarter of the Northeast Quarter, and except that part of the East Half of Southwest Quarter of the Northeast Quarter described as follows: Beginning at the Southeast corner of the East Half of Southwest Quarter of Northeast Quarter; thence West along the South line thereof 294.76 feet to the point of beginning; thence West along the South line 205.24 feet; thence North parallel with the East line of the East Half of the Southwest Quarter of the Northeast Quarter 243.0 feet; thence East parallel with the South line 205.24 feet; thence South parallel with the East line 243.0 feet to the point of beginning,

the village council has unanimously determined that it is to the best interest of the village and to the best interest of the property to be annexed that it be annexed.


Section 2. The tract hereinbefore described is, by this Ordinance, declared to be annexed to the Village of Delano, Minnesota.

Section 3. This Ordinance shall take effect upon its passage and publication, and upon the filing of a copy of this Ordinance with the Municipal Commission of the State of Minnesota, the County Auditor of Wright County, and the Secretary of State of the State of Minnesota.
