ORDINANCE NO. 1778 AN JORDINANCE ANNEXING TO THE CITY OF ROCHESTER MINN-ESOTA, CERTAIN PLATTED LAND IN NORTH SUNNY SLOPES, OLM-STED COUNTY, MINNESOTA. THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:

THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN: Section 1. A petition has been filed with the Common Council of the City of Rochester, signed by a majorit' of the owners of land described herein, re-questing the Common Council to Ennext said land to the City of Rochester. The land described in said petition for annexation is located in Rochester Township, Olmsted County, Minne-sota, and is described as follows: Lots 24 and 25, North Sunny Slopes, and the north haid of the town road adjoining said lots, according to the plat thereof on file and of record in the office of the Register of Deeds In and for said County. Said petition has also been filed with the Town Board of Rochester Town-ship, with the County Board of the County of Olmsted, and with the Min-nesota Municipal Commission, and the Town Board of Rochester has notified the City that it has no objections to the annexation of the above-described land.

annexation of the above-described land, Section 2. The quantity of land in-cluded in said petition is approximate-ily 1.67 acres. Section 3. The Common Council of the City of Rochester does horeby dotermine that the land described in Section 1 abuts upon the present terri-torial limits of the City of Rochester, is so conditioned as to be properly sub-jected to municipal government, and the annexation of said land will be in the best interest of the City of Rochester and the land described. Section 4. Therefore, the land de-scribed in Section 1 above is hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if it had originally been a part thereof.



Present and future owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the inten-tion of the Common Council to assess against benefitted property, all or a portion of the cost of any storm sewer water tower and trunk line sanitary sewer construction, heretofore or here-after undertaken to serve the area annexed.

Pursuant to Rochester-Code of Ordinances, 550,506, as en-acted by Ordinance No. 1659, known as the Zoning Ordinance of the City of Rochester, the land herein annexed to the City of Rochester is zoned R-Sa Estate A District. Section 7. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the Rochester Town Gerstary of State.
