



ORD. NO. 465

AN ORDINANCE ANNEXING REAL ESTATE OWNED  
BY THE CITY OF MONTEVIDEO

THE CITY OF MONTEVIDEO DOES ORDAIN:

1. The City of Montevideo being the sole owner as vendee under a Contract for Deed of that certain tract of land in the County of Chippewa and State of Minnesota, described as follows:

A tract of land in the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West, commencing at the intersection of the north line of Windom Avenue in the City of Montevideo and the east line of Thirteenth Street in said City extended northerly, thence north along the east line of Thirteenth Street extended to the north line of said Southwest Quarter (SW $\frac{1}{4}$ ), thence west along the north line of said Southwest Quarter (SW $\frac{1}{4}$ ) to the intersection of said north line with the west line of Eleventh Street in the City of Montevideo extended northerly, thence south along the west line of Eleventh Street extended northerly to its intersection with the north line of Windom Avenue in said City, and thence east along the north line of Windom Avenue to the point of beginning, containing 12.05 acres, more or less.

Pursuant to Minnesota Statutes 414.033, subdivision 2, the same is hereby declared to be annexed to the City of Montevideo and included within its corporate limits.

2. This Ordinance shall take effect from and after its passage and publication as provided by the Charter of the City of Montevideo.



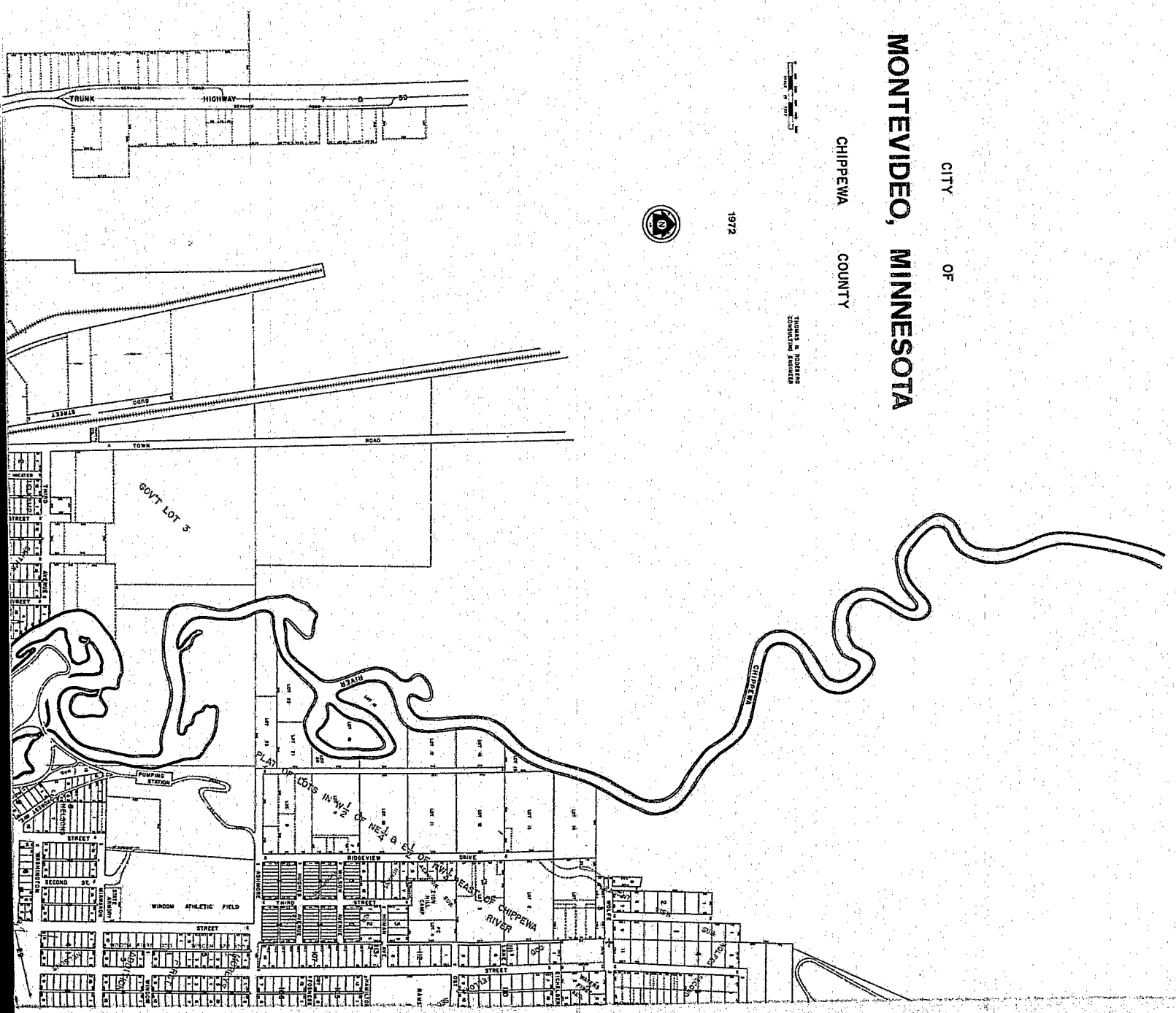

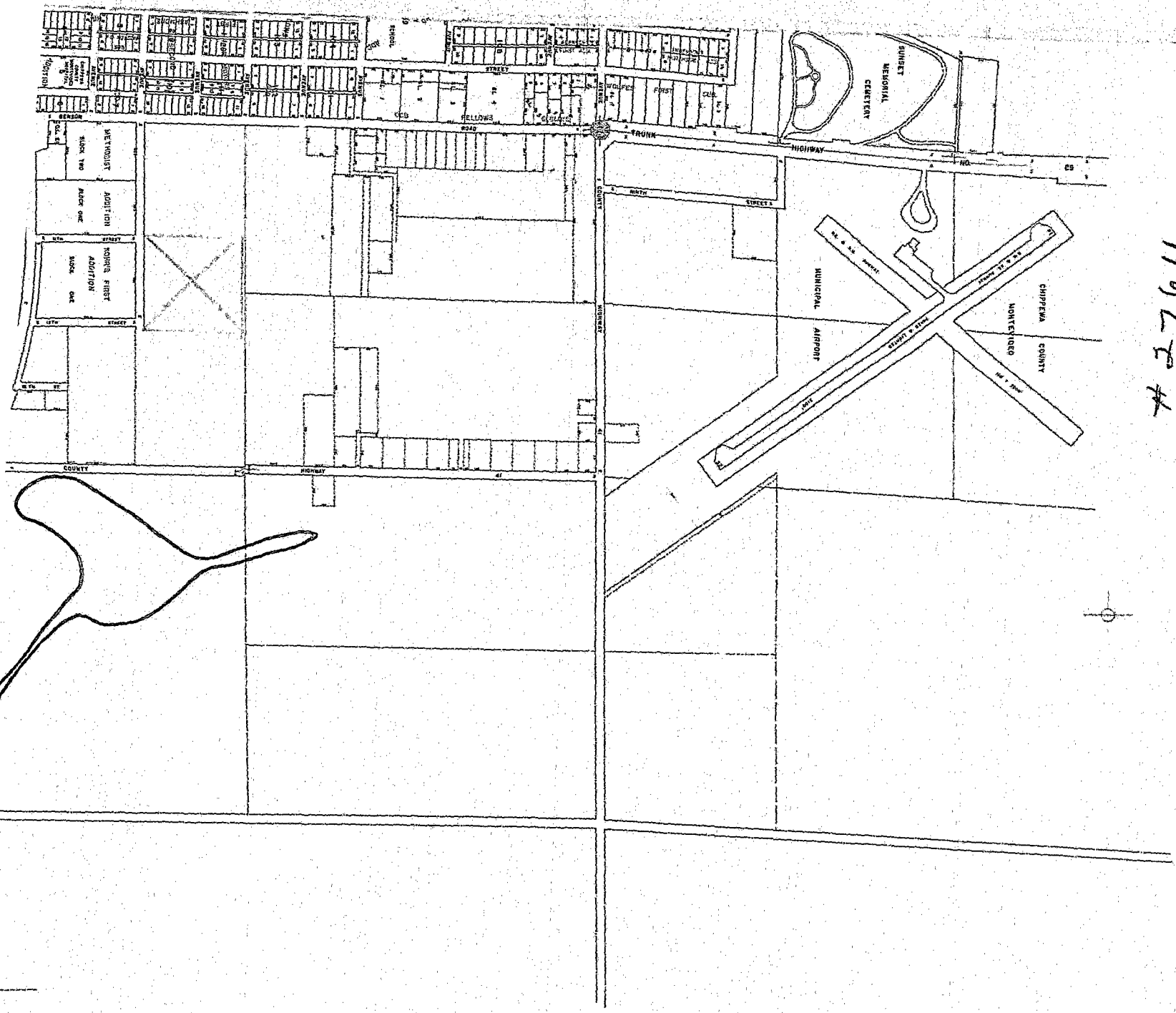
