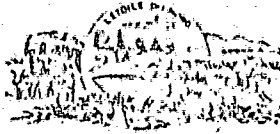

AN AMENDMENT TO A CERTAIN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF PINE CITY.

The City Council of the City of Pine City does ordain as follows:

Section 1. The ordinance heretofore enacted for the City of Pine City on September 13, 1974 annexing certain lands to the City of Pine City is hereby amended to read as follows:

The following described land abutting the City of Pine City and owned by the City of Pine City, is hereby declared annexed to the City of Pine City:

Northwest Quarter of the Northwest Quarter (NW¹/₄ of NW¹/₄) Section Twenty-seven (27), Township Thirty-nine (39), Range Twenty-one (21).

The North Half of the Northeast Quarter (N¹/₂ of NE¹/₄) East of Railway, Section Twenty-eight (28), Township Thirty-nine (39), Range Twenty-one (21), except that part thereof heretofore annexed.

The West Half of the Southeast ~~Southwest~~ Quarter (W¹/₂ of SE¹/₄ SW¹/₄), Section Twenty-two (22), Township Thirty-nine (39), Range Twenty-one (21); and that part of the South Half of the Southeast Quarter (S¹/₂ of SE¹/₄), Section Twenty-one (21), Township Thirty-nine (39), Range Twenty-one (21), Easterly of the railroad.

Section 2. This Ordinance shall be effective from and after its passage and publication, and the filing of a copy hereof with the Minnesota Municipal Commission, the Clerk of the Town of Pokegama, the County Auditor of the County of Pine and the Secretary of State of the State of Minnesota.

The West Half of the Southeast Quarter (W $\frac{1}{2}$ of SE $\frac{1}{4}$) Section Twenty-two (22), Township Thirty-nine (39) Range Twenty-one (21); and that part of the South Half of the Southeast Quarter (S $\frac{1}{2}$ of SE $\frac{1}{4}$), Section Twenty-one (21), Township Thirty-nine (39), Range Twenty-one (21), Easterly of the railroad.
