

ORDINANCE NO. 139

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HECTOR TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

The City Council of Hector, Minnesota ordains:

SECTION 1. Territory Annexed. The corporate limits of the City of Hector, Minnesota, are hereby extended to include the platted territory described as follows, which territory is now and has heretofore been completely surrounded by territory already included within the City limits:

Lot Two (2), of the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of Section Twenty-Nine (29), Township One Hundred Fifteen North (115N), Range Thirty-Two West (32W).

SECTION 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

SECTION 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.

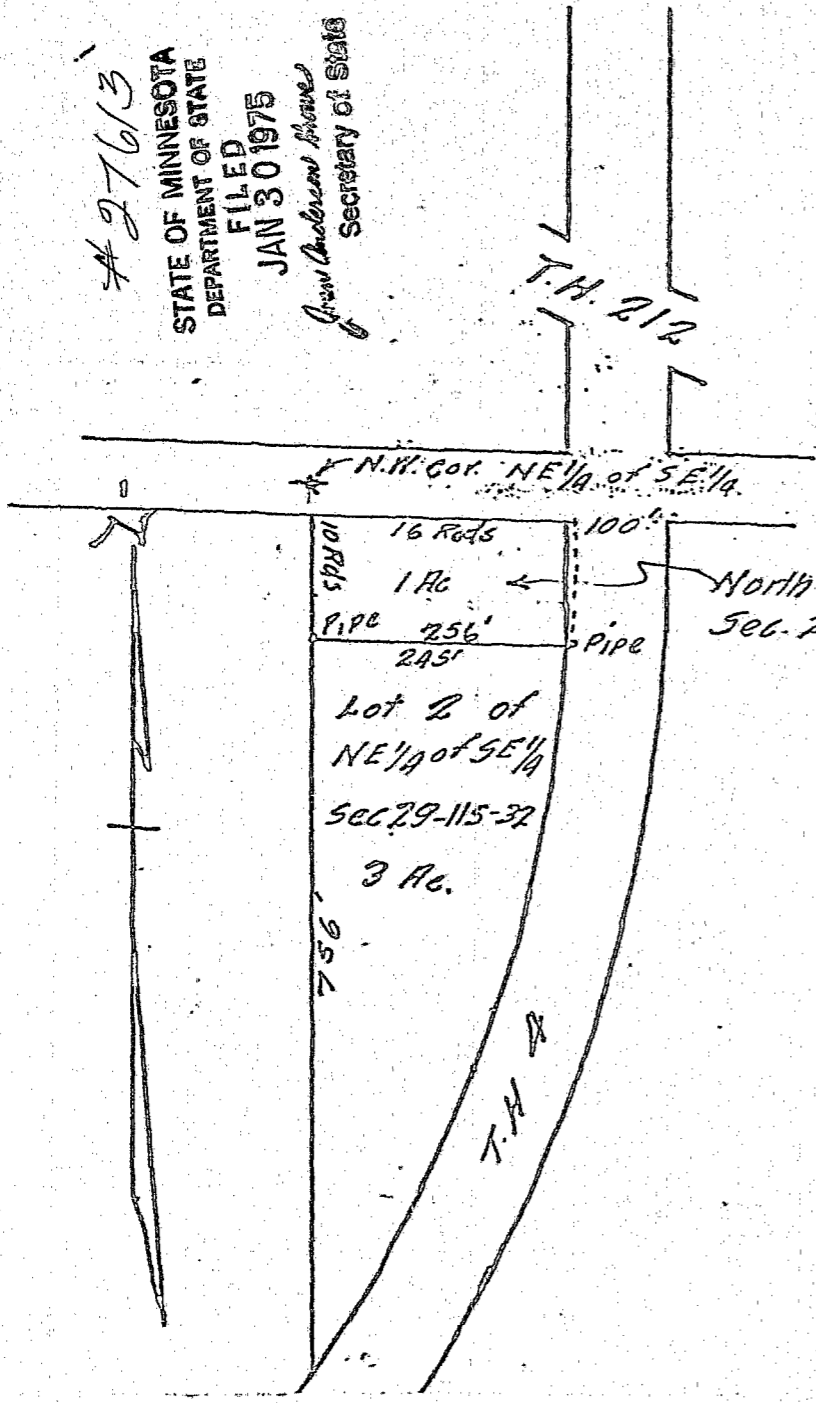
