The Ministry For Foreign Affairs

of

The Republic of Finland

hereby makes known

that to promote the friendship and commercial relations existing between the Republic of Finland and the United States of America, it has been determined that it is good and desirable that Mr. Donald Glen Wirtanen should act as Consul of the Republic of Finland

in Duluth

and for that reason by virtue of authority vested in me by the Government of the Republic, I name and appoint him to that position. I ask that Consul Wirtanen in the country in which he is stationed be accorded credibility and good will, and that particularly the local Government officials accord him all the help which he requires in the performance of his official duties, and that they will accord him the privileges and courtesies which his official position calls for and which are accorded to the Consuls of other States.


Dear Mr. Wirtanen,

Your Certificate of Appointment is being sent to you under separate cover.

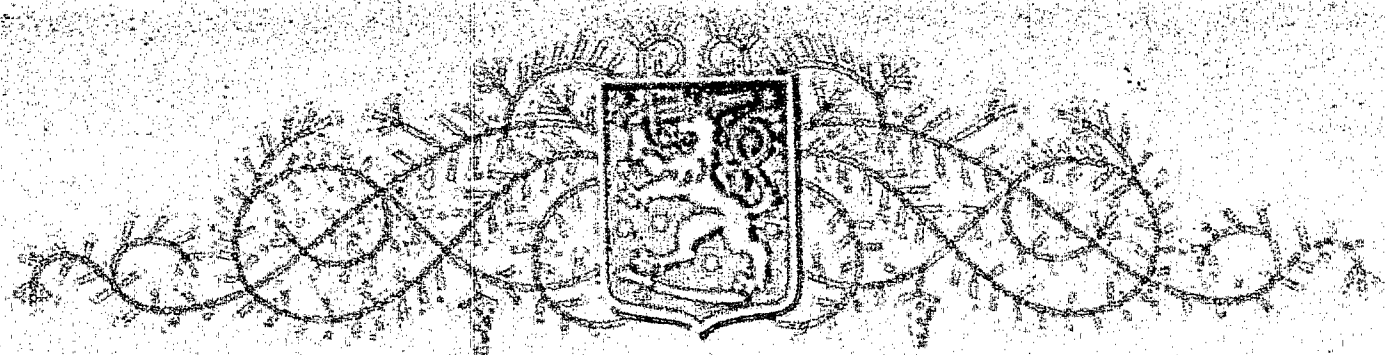
