ORDER FOR RETIREMENT

WHEREAS, the said Judge Douglas P. Hunt has submitted evidence that he has served as such judge, or as such judge and as such judge of a court of record, for more than 38 years,

NOW, THEREFORE, I, Wendell R. Anderson, Governor of the State of Minnesota, acting pursuant to the provisions of M.S. 490.12 (1971), do hereby order and direct the retirement of the Honorable Douglas P. Hunt, to become effective at midnight on January 5, 1975. He shall become entitled thereafter to retirement compensation as provided under the law, and I further direct that this Order be filed in the Office of the Secretary of State of the State of Minnesota.


