ORDINANCE NO. 129

AN ORDINANCE RELATING TO ANNEXATION

The City Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory

The following-described territory is hereby annexed to the City of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:


Beginning at a point on the West line of the Northwest Quarter (NW $\frac{1}{4}$) of Section Thirty-four (34) Township One Hundred Six (106), North, Range Thirty-four (34) West of the 5th P.M., in Cottonwood County, Minnesota, a distance of One Thousand Two Hundred Sixty-eight and five-tenths (1268.50) feet North of the Southwest corner of said Northwest Quarter (NW $\frac{1}{4}$); thence North along said West line a distance of Four Hundred Eighty-two (482) feet; thence South 89° 32' 40" East along a line parallel with the South line of said Northwest Quarter (NW $\frac{1}{4}$), a distance of Seven Hundred Twenty-three feet (723.00); thence South along a line parallel with said West line of said Northwest Quarter (NW $\frac{1}{4}$) a distance of Four Hundred Eighty-two (482) feet; thence North 89° 32' 40" West along a line parallel with the South line of said Northwest Quarter (NW $\frac{1}{4}$) a distance of Seven Hundred Twenty-three (723.00) feet to the point of beginning; said tract containing 8.00 acres, more or less.

(Containing approximately eight (8) acres; including abutting roads and rights-of-way; and which tract abuts upon the City of Mountain Lake, Minnesota.)

Section 2. Effective Date

This Ordinance becomes effective on the date of its passage.

Passed by the City Council, this 10th day of December, 1974.


