AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN  
LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is .74 acres, more or less, of platted land, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the Petition was signed by all the owners of the premises therein described; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City Limits at the northerly boundary thereof; and

WHEREAS, the land described in said Petition was purportedly annexed to the City of Montevideo by Chapter 295 of the Ordinances of the City of Montevideo but the validity of said Ordinance has been questioned; and

WHEREAS, the City desires to perfect the annexation of the hereinafter described tracts covered by said Petition;

The City of Montevideo does ordain:

Section 1. Determination by City Council: The City Council hereby determines: (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City Limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed: The corporate limits of the



City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

The West Half (W $\frac{1}{2}$ ) of Lot Five (5) of Block Three (3) of Ira B. Wolfe's Second Subdivision in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$  SE $\frac{1}{4}$ ) of Section Six (6), Township One Hundred Seventeen (117), Range Forty, Chippewa County, Minnesota, containing 0.29 acres, more or less,

and

Lot Four (4) of Block Four (4) of Ira B. Wolfe's Second Subdivision in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$  SE $\frac{1}{4}$ ) of Section Six (6), Township One Hundred Seventeen (117), Range Forty (40), Chippewa County, Minnesota, containing 0.45 acres, more or less.

Section 3. Zoned Residential: That said premises are hereby annexed to and made a part of the City of Montevideo and are zoned as R "Residential District".

Section 4. Filing: The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk of Sparta Township, the County Auditor and the Register of Deeds for Chippewa County.

Section 5. Effective Date: This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
