COMMISSIONER'S ORDER

NO. 34

Pursuant to the provisions of Minnesota Statutes, Section 168.09, Subdivision 3 (1974) the latest date for display of 1975 registration plates for vehicles registered pursuant to the provisions of Minnesota Statutes Section 168.187 (1974) (proportional registration) is extended to 12:01 a.m., April 1, 1975. Thereafter, all such vehicles required to be registered shall display evidence of 1975 registration.

This order does not in any manner change the tax due date nor any penalty provisions for delayed registration which have been in effect since January 11, 1975, the due date for payment of the registration fee without penalty.

This order has no effect on the statutory requirement of Minnesota Statutes Section 168.09, that all other vehicles must display evidence of 1975 registration by 12:01 a.m., March 2, 1975.

Pursuant to the provisions of Minnesota Statutes, Section 168.09, Subdivision 3, as amended by Chapter 1, Laws of Minnesota, 1971, the latest date for display of 1970 registration plates and plates validated with 1970 stickers is extended to 12:01 A.M., March 23, 1971. Thereafter, all vehicles required to be registered must display evidence of 1971 registration.

This order does not in any manner change the tax due date nor the penalty charges for delayed registration which have been in effect since January 11, 1971, the due date for payment of the tax without penalty.
