

PROPOSED ORDINANCE NO. 201

ORDINANCE ANNEXING ADJOINING LANDS

The City Council of the City of Madison does ordain:

Section 1: That the following described land adjoining the limits of the City of Madison, located in the County of Lac qui Parle, State of Minnesota, is hereby added to, taken into and made a part of the City of Madison, to-wit:

The West 355 feet of Lot Ten (10) in Evergreen Addition to Madison, according to the plat thereof on file and of record in the office of the Register of Deeds of said County, said land being situated in the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Twenty-One (21), Township One Hundred Eighteen North (118N) of Range Forty-Four (44) West of the Fifth Principal Meridian in Minnesota, together with that part of the City of Madison street dedicated as Park Avenue and the Madison Township road right of way located between said Lot Ten (10) and the present corporate limits of the City of Madison,

Section 2: That on the taking effect of this ordinance the corporate limits and boundary lines of the City of Madison shall be and are extended to include said tracts of land.

Section 3: This ordinance shall be in full force thirty days from and after its passage.
