





ORDINANCE NO. A-75-114

AN ORDINANCE TO AMEND AN ORDINANCE KNOWN AS CHAPTER 13, UNCODED ORDINANCES IN EFFECT, OF THE CITY CODE OF THE CITY OF MANKATO, MINNESOTA.

The City of Mankato, Minnesota, hereby ordains:

WHEREAS, a petition was duly filed with the City Clerk requesting annexation of the Territory hereinafter described; and

WHEREAS, the petition was signed by Minnesota Gas Co., Raymond J. Rausch, Josephine M. Rausch and Richard A. Ellingson, representatives of said property; and

WHEREAS, said petition was examined by the Engineering Department of the City of Mankato, and then duly considered by the Planning Commission; and

WHEREAS, at least sixty days have transpired since the filing of the petition and no objections to the annexation have been received from the Town Board nor the County Board; and

WHEREAS, the quantity of land embraced within the area described in the petition, and bounded as described, is approximately 37.8 acres of unplatted land, no part of which is included within the limits of an incorporated municipality; and

WHEREAS, the land described in the petition abuts upon the City limits at the easterly boundary thereof, and is or is about to become urban or suburban in character;

The City Council hereby determines that the annexation will be to the best interests of the City and of the territory affected; and hereby orders that the corporate limits of the City are hereby extended to include the land described as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Fourteen and one-half (14.5) acres of land located in the south half of Northwest Quarter of Section 5, Township 108 North, Range 26 West, Blue Earth County, Minnesota;

Five and nine-tenths (5.9) acres of land located within the Southeast Quarter of the Northwest Quarter of Section 5, Township 108 North, Range 26 West, Blue Earth County, Minnesota;

Six (6.0) acres of land located in part of the South half of the Northwest Quarter of Section 5, Township 108 North, Range 26 West, Blue Earth County, Minnesota;

Four (4.0) acres of land located in part of the South half of the Northwest Quarter of Section 5, Township 108 North, Range 26 West, Blue Earth County, Minnesota;

Seven and four-tenths (7.4) acres of land located in part of the South half of the Northwest Quarter of Section 5, Township 108 North, Range 26 West, Blue Earth County, Minnesota.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

This ordinance shall take effect thirty (30) days from the date of its adoption, due publication thereof, and due filing thereof.
