ORDINANCE NO. 255

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE
CITY OF REDWOOD FALLS

THE CITY OF REDWOOD FALLS DOES ORDAIN:

1. That it is hereby found and determined:

(A) That the lands hereinafter described abut on the City of Redwood Falls; that said lands are less than two hundred acres in area and are unplatted; and that a Petition for Annexation of said lands to the City of Redwood Falls is on file in the office of the Redwood Falls City Clerk and has been signed by the owner of said lands.

(B) That said lands are urban in character.

(C) That said lands are suitably conditioned for municipal government.

(D) That it is for the best interests of the City of Redwood Falls and the owner and residents of said lands that the same be annexed to the City of Redwood Falls.

2. That the following described lands lying and being in the County of Redwood and State of Minnesota, are hereby annexed to the City of Redwood Falls:

All that part of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-two (32), Township One Hundred Thirteen (113) North, Range Thirty-five (35) West, described as follows:

Commencing at the Southeast corner of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-two (32) and running thence North along the East line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-two (32) a distance of 500 feet, thence West parallel with the South line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-two (32) to the center of Redwood County State Aid Highway No. 101, thence Southwesterly along the center line of said Redwood County State Aid Highway No. 101 to the South line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-two (32), thence East along the South line of said Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-two (32) to the point of beginning.
