

ORDINANCE NO. 233

AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO BE ANNEXED
TO THE CITY OF ST. JAMES, MINNESOTA

BE IT ORDAINED by the City of St. James, Minnesota as follows:

- (1) The tracts of land lying adjacent to the City of St. James and being in the County of Watonwan and described as follows are hereby annexed and declared to be a part of the City of St. James and to be included in the corporate minutes thereof:

Beginning at the point of intersection of the Northerly right-of-way of Sunset Drive and the Westerly right-of-way of Willow Vue Drive in Willow Vue Subdivision, St. James, Minnesota; thence South 37 degrees 15 minutes, 18 seconds, East 60 feet; thence South 52 degrees, 08 minutes, 42 seconds West, 38.80 feet; thence North 37 degrees, 51 minutes, 18 seconds West to the shore of St. James Lake; thence Easterly along said lakeshore to a point of intersection with the West line of said Willow Vue Subdivision; thence Southerly along said West line to the point of beginning.

- (2) This Ordinance shall take effect from and after date of passage and publication.
