RESOLUTION OF ORDINANCE OF ANNEXATION.

WHEREAS, Edward Rivers, Jr., and Viola Rivers, husband and wife, are the sole owners of the hereinbefore described real estate located in Rollingstone Township, Winona County, Minnesota.

AND WHEREAS, The said Edward Rivers, Jr., and Viola Rivers, husband and wife, have petitioned the City of Rollingstone, Minnesota, for an ordinance of annexation of the said real estate to the said City of Rollingstone, and copies of said petition have been filed with the Minnesota Municipal Commission, with the Township of Rollingstone, and with the County of Winona; and more than sixty (60) days have expired since said petitioning and said filing of copies, and no written objections to such annexation have been received.

AND WHEREAS, The said real estate is urban in character, and the north boundary line thereof is adjacent to and abuts the City Limits of the said City of Rollingstone, and the said real estate is unplatet and does not exceed 200 acres and is in fact 0.26 acres more or less.

AND WHEREAS, It would be in the best interests of the development of said real estate and in the best interests of the City of Rollingstone to have the said real estate annexed to the said City of Rollingstone.

NOW THEREFORE, BE IT RESOLVED, By the City of Rollingstone, Minnesota, that it does hereby by ordinance declare the annexation to the City of Rollingstone, Minnesota, of the parcel of real estate described as follows, to-wit:

That part of Lot Thirty-six (36) of the Subdivision of Southwest Quarter (SW $\frac{1}{4}$) of Section Five (5), Township One Hundred Seven (107) North, Range Eight (8) West, Winona County, Minnesota, which lies east of the center line of Cleveland Street if said center line of Cleveland Street were projected southerly and which lies north of the northerly right-of-way line of Trunk Highway No. 248, containing 0.26 acres more or less.
