ORDINANCE NO. 106

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DORAN TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY OF DORAN.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village or borough; and
WHEREAS, this territory abuts upon the corporate limits of the city of Doran at the east boundary thereof and is deemed to be urban in character; and
WHEREAS, this territory is owned in fee by the city of Doran;

The city council of Doran ordains:

Section 1. Territory Annexed. The corporate limits of the city of Doran are hereby extended to include the unplatted property described as follows now owned by the city of Doran.

Part of the Southeast one quarter of section five in Township one hundred thirty one north of range forty six west of the fifth principal meridian, described as follows: (SE 1/4-5-131-46) Commencing at Northwest corner of said SE 1/4-5-131-46 running thence south on the quarter section line 49 rods to a point where the said quarter section line intersects the east line of the townsite of Doran; running thence southeasterly along said townsite 31 rods and 10 feet to the point of beginning; thence northeasterly at right angles with said east line of said townsite of Doran 16 rods; thence south and east parallel with said east line of said townsite of Doran 25 rods; thence south and west at right angles 16 rods to a point on said east line of said townsite of Doran; thence north and west ~~along~~ along said east line of said townsite of Doran 25 rods to the point of beginning.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Wilkin County, the Township Clerk of Brandrup Township and the Minnesota Municipal Commission.

Section 3. Name of Annexation. From henceforth this property shall be known as The School Addition to the City of Doran.

Section 4. Effective Date of Annexation. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in section 2.
