

ORDINANCE NO. 68

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RAYMOND, MINNESOTA, TO INCLUDE CERTAIN LAND PLATTED AND DESCRIBED AS "EAST SIDE ADDITION TO RAYMOND".

WHEREAS, the sole owner of certain real property located in Kandiyohi County, Minnesota, described as follows:

All that part of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Nineteen (19), Township One Hundred Eighteen (118), Range Thirty Six (36), described as follows: Beginning at the Northeast corner of DeJong's Third Addition to Raymond, as of public record; thence on an assumed bearing of South 0 $^{\circ}$  16' West, along the East line of said DeJong's Third Addition and DeJong's Second Addition, as of public record, a distance of 708.33 feet to the North line of C.S.A.H. No. 7; thence on a bearing of North 87 $^{\circ}$  45' East, along last said line, 593.34 feet; thence on a bearing of North 0 $^{\circ}$  02' East, parallel with and 13  $\frac{1}{3}$  rods West of the East line of said Section Nineteen (19), a distance of 855.78 feet; thence on a bearing of South 87 $^{\circ}$  59' West, 589.76 feet; thence on a bearing of North 0 $^{\circ}$  16' East, 50 feet; thence on a bearing of South 87 $^{\circ}$  59' West, 360 feet to the East line of DeJong's Addition to Raymond, as of public record; thence on a bearing of South 0 $^{\circ}$  16' West, along last said line, 200 feet to the North line of 1st Avenue, as platted in said DeJong's Third Addition; thence on a bearing of North 87 $^{\circ}$  59' East, along last said line, 360 feet to the point of beginning, which property contains an area of approximately 13.3 acres and has been platted as East Side Addition to Raymond,

has filed a petition requesting that the said property be annexed to the City of Raymond; and

WHEREAS, the premises are adjacent to the present corporate limits of the City of Raymond, Minnesota; and

WHEREAS, copies of such petition have duly been filed with the Minnesota Municipal Commission, the Town Board of Edwards Township, the County Board of Kandiyohi County, more than 60 days has elapsed since the petition was filed with such bodies, and no objection has been made to such annexation; and

WHEREAS, it is determined by the City Council of the City of Raymond,

Minnesota, that such annexation will be to the best interests of the City of  
Raymond and of the property herein described,

THEREFORE, IT IS HEREBY ORDAINED AND DECLARED AS FOLLOWS:

SECTION 1. The property hereinbefore described shall be and hereby is annexed to and included in the City of Raymond, Minnesota, as effectually as if it originally had been a part thereof.

SECTION 2. This ordinance shall be final and shall take effect and be in full force from and after the filing of a copy thereof with the Minnesota Municipal Commission, the Town Clerk of Edwards Township, Kandiyohi County, Minnesota, the County Auditor of Kandiyohi County, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.


