

ORDINANCE NO. 562

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA WHICH IS BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THERE-
ON

WHEREAS, the land herein after described is not included within the boundaries of any incorporated municipality, and,

WHEREAS, the permiter of the land herein after described is sixty percent or more bordered by the City of White Bear Lake, and,

WHEREAS, pursuant to Minnesota State Statutes, 4014.033, Subdivision 3, a notice was duly served upon the Board of Town of White Bear that the City of White Bear Lake intends to annex said land by ordinance, and,

WHEREAS, the Town of White Bear has waived the sixty day waiting period and no objections to the annexation have been filed with the City of White Bear Lake or the Minnesota Municipal Commission, and,

WHEREAS, the City Council feels that such annexation will be in the best interests of the City of White Bear Lake and of the territory affected.

NOW, THEREFORE, BE IT RESOLVED the Council of the City of White Bear Lake, Minnesota does ordain:

1. The following described land situated in Ramsey County, Minnesota, to-wit:


The East 663 feet of the South East quarter of the South East quarter of Section 36, Township 30 North, Range 22 West, subject to the right of way of County Road D, and State Trunk Highway 120.

Be, and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That upon the effective date of this ordinance, such land shall become a part of said City as if it had been originally thereof.

3. This ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication, and after a copy of such is filed with Ramsey County, Secretary of State of the State of Minnesota, and the Minnesota Municipal Commission.





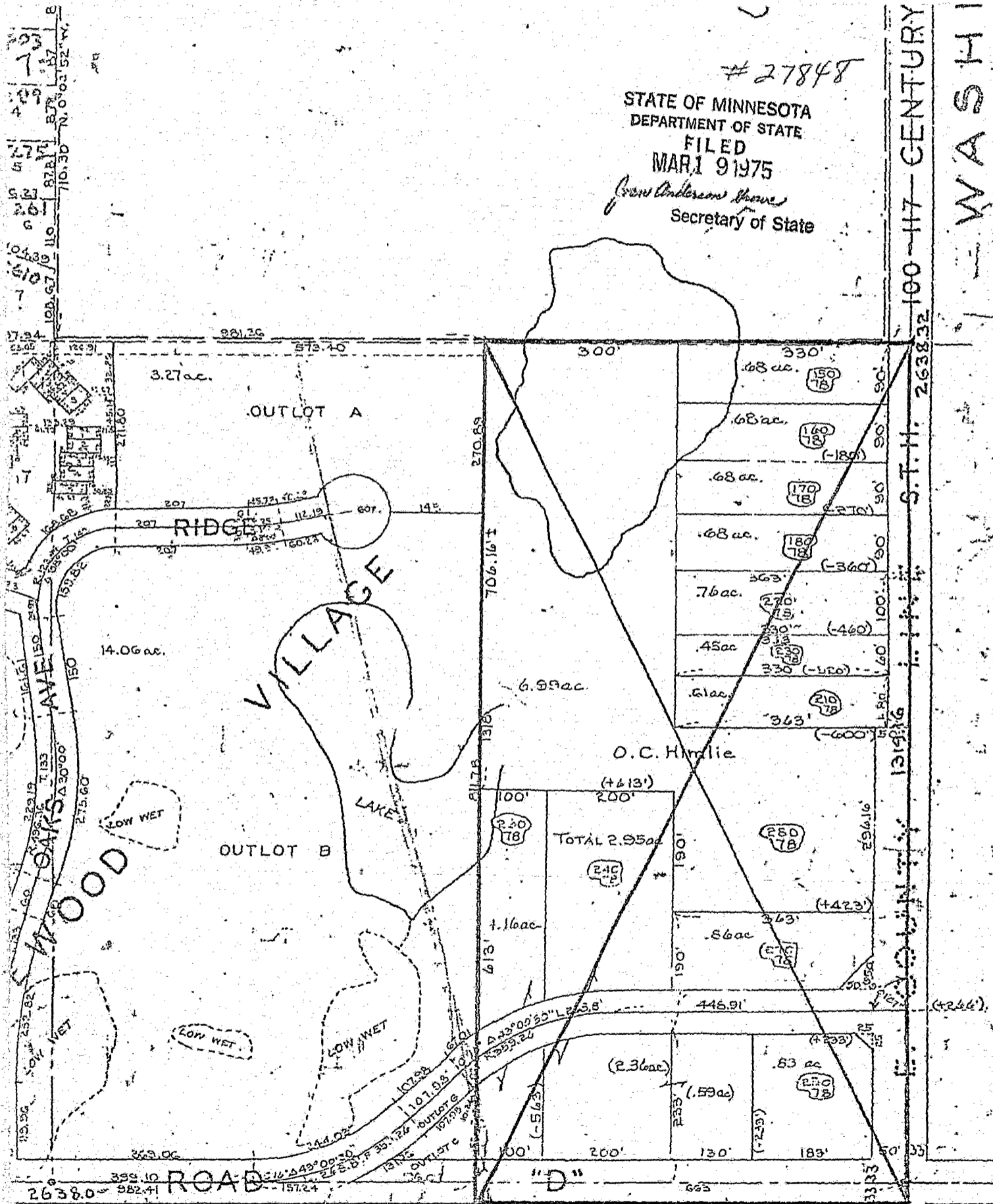
