## • ORDINANCE NO. A-74-112

AN ORDINANCE TO AMEND AN ORDINANCE KNOWN AS CHAPTER 13, UNCODED ORDINANCES IN EFFECT, OF THE CITY CODE OF THE CITY OF MANKATO, MINNESOTA.

The City of Mankato, Minnesota, hereby ordains:

WHEREAS, a petition was duly filed with the City Clerk requesting annexation of the territory hereinafter described; and

WHEREAS, the petition was signed by Phillips Marketing Properties, Inc., Marvin L. Collins and Perry J. Dickey, Vice President and Attorneyin-Fact, respectively, of said property; and

WHEREAS, said petition was examined by the Engineering Department of the City of Mankato, and then duly considered by the Planning Commission; and

WHEREAS, at least sixty days have transpired since the filing of the petition and no objections to the annexation have been received from the Town Board nor the County Board; and

WHEREAS, the quantity of land embraced within the area described in the petition, and bounded as described, is approximately 2.5 acres of unplated land, no part of which is included within the limits of an incorporated municipality; and

WHEREAS, the land described in the petition abuts upon the City limits at the Northwesterly boundary thereof, and is or is about to become urban or suburban in character;

The City Council hereby determines that the annexation will be to the best interests of the City and of the territory affected; and hereby orders that the corporate limits of the City are hereby extended to include the land described as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Commencing at the Northeast corner of the North east Quarter (NE4) of the Northwest Quarter (NW4) of Section 1, Township 108 North, Range 27 West, thence West on the North line of said Section 1, a distance of 458.4 feet to a point on the westerly right-of-way line of the new highway, said point being the place of beginning, thence continuing west on the North line of said Section1, a distance of 226.6 feet to the center line of the County Road 73; thence deflecting left  $103^{\circ}21$ ' and along the center line of said County Road, a distance of 435.9 feet; thence deflecting left  $76^{\circ}39$ ' and parallel with the North line of said Section 1, a distance of 290.8 feet to the Westerly right-of-way line of the new highway; thence northerly on the westerly right-of-way line of the new highway to the place of beginning. Subject to easement for service road on the East 33 feet of said tract, subject to all the covenants of said assignor in said contract contained.
