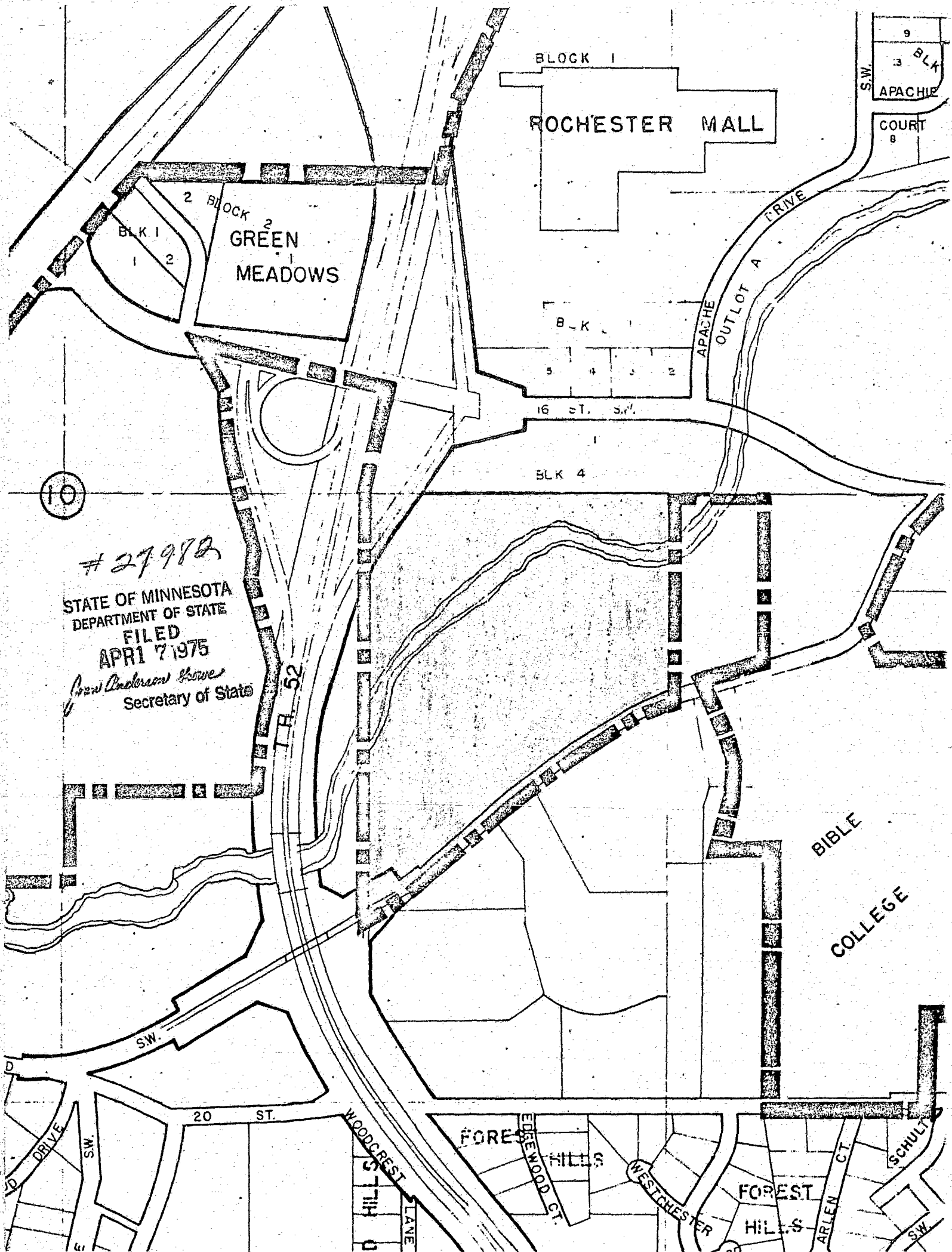

ORDINANCE NO. 7487 1787
AN ORDINANCE ANNEXING TO THE
CITY OF ROCHESTER, MINNE-
SOTA, CERTAIN UNPLATTED
LAND IN SECTION 10, TOWNSHIP
106 NORTH, RANGE 14 WEST,
OLMSTED COUNTY, MINNESOTA.
THE COMMON COUNCIL OF THE
CITY OF ROCHESTER DO ORDAIN:
Section 1. The City of Rochester,
Minnesota, is owner of the land herein-
after described located in Rochester
Township, Olmsted County, Minne-
sota, and which abuts the present
territorial limits of the City of
Rochester:
That portion of the East half of the
Southeast Quarter of Section 10,
Township 106 North, Range 14
West, which lies north of the cen-
terline of Maywood Road
Southwest.
Section 2. The quantity of land de-
scribed in Section 1 is approximately
41.9 acres in area.
Section 3. The Common Council of
the City of Rochester hereby de-
termines that the land described in
Section 1 abuts the present territorial
limits of the City of Rochester and is
hereby annexed, added to, and made a
part of the City of Rochester, Minne-
sota, as effectually as if it had
originally been a part thereof.
Section 4. This ordinance shall take
effect and be in force from and after
its official publication and from and
after the filing of a certified copy
hereof with the Minnesota Municipal
Commission, the Clerk of the Town of
Rochester, the Olmsted County
Auditor, and the Secretary of State.
