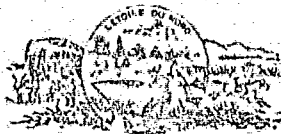



AN ORDINANCE ANNEXING
CERTAIN PROPERTY TO THE
CITY OF BROWNTON,

THE CITY COUNCIL OF
THE CITY OF BROWNTON
DO ORDAIN AS FOLLOWS:

THAT THE PREMISES AD-
JOINING THE CITY LIMITS
OF THIS CITY AND DESCRIB-
ED AS FOLLOWS:

Beginning at a point 640
feet north of southeast corner
of the Northeast Quarter of
the Northwest Quarter of Sec-
tion 32 in Township 115 North
of Range 29 West of the 5th
P.M., and thence west 158
feet; thence South 111.3 feet;
thence east 158; thence north
111.3 feet to the point of be-
ginning, said premises being
also know and described as
Lot (1) and the North 33.7
feet of Lot Two (2), and the
North 84.3 feet of Lot Thir-
teen (13), all in Block One
(1) in Auditor's Plat of the
Northeast Quarter of the
Northwest Quarter of Section
32, Township 115 North of
Range 29 West, except Zim-
merman's Addition, according
to the plat thereof on file and
of record in the office of the
Register of Deeds, McLeod
County, Minnesota together
with the unopened street ly-
ing to the North of said tracts.
