

I am pleased to announce that by a decree, of which a corresponding certified photocopy is attached, the King has bestowed upon you, on my proposal, the title of Belgian Consul in Minneapolis, with a constituency covering the states of Minnesota, North Dakota, and South Dakota.

Also enclosed is the letter of provision for that which you are destined. The Belgian Embassy in Washington will take the necessary steps to have you recognized by the American authorities.

I call your attention to the clauses from Volume I, Title VII, Chapter II, of the Manual for diplomatic missions and consular posts regarding the reimbursable expenses for honorary consuls which must be made the object of expense statements, in duplicate, accompanied by vouchers, to be transmitted to my Department by the intermediary of the Belgian Embassy in Washington at least once a year, in the first two weeks of January.

I am also notifying you that by virtue of a regulation applicable to honorary Belgian consuls abroad, you can hold this title until the age of 70, at which time you must tender your resignation.

I am convinced that you will not neglect any efforts beneficial to the mission entrusted with you, and especially that you will use all your authority in the defense of our commercial interests.




