AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HALSTAD TO INCLUDE CERTAIN UNPLATTED LAND HEREIN DESCRIBED AND LOCATED IN SECTION THIRTY (30) OF HALSTAD TOWNSHIP, NORMAN COUNTY, MINNESOTA,

WHEREAS, A Petition was presented to, and filed with, the City Council of the City of Halstad on October 28, 1974, copies of said Petition also having been filed on October 28, 1974, with the Town Board of the Township of Halstad and with the County Board of Norman County and with the Municipal Commission of Minnesota, which Petition was signed by all of the owners of the tract of land described therein, said tract not exceeding forty (40) acres in area, and which requested the Annexation of said tract to the City of Halstad; and whereas, no objections to the Annexation thereof were received within sixty (60) days thereafter from the Township of Halstad, Norman County, or any other municipalities, now therefore,

THE CITY COUNCIL OF THE CITY OF HALSTAD, MINNESOTA, DOES HEREBY ORDAIN: Section 1. DECLARATION. It is hereby determined that the hereinafter described tract is unplatted land not exceeding forty (40) acres in area; that said tract abutts on the South and East boundaries of the City of Halstad and is not presently included within the corporate limits of any municipality; that said tract is urban in character; and that the Annexation thereof would be in the best interests of the City of Halstad and said tract and the owners thereof.

Section 2. TERRITORY ANNEXATION. The corporate limits of the City of Halstad are hereby extended to include the tract of land in the County of Norman and State of Minnesota described as follows:

> Commencing at the Southeast corner of the Original Townsite of the City of Halstad, Norman County, Minnesota; thence Easterly, parallel with the South line of the Northeast Quarter (NEL) of Section Thirty (30) in Township One Hundred Forty-five (145), Range Forty-eight (48), to the North-South centerline of said Northeast Quarter (NE<sup>1</sup>4); thence North on said North-South centerline to the Northeast Corner of the Northwest Quarter of the Northeast Quarter (NW14NE14) of said Section Thirty (30); thence Easterly on the North line of said Section Thirty (30) for a distance of 389.09 feet, more or less, to a point 1,710 feet East of the Northwest Corner of the Northeast Quarter (NE15) of said Section Thirty (30); thence Southerly, parallel with the West line of the Northeast Quarter (NE<sup>1</sup><sub>4</sub>) of said Section Thirty (30), for a distance of 1,866 feet; thence Westerly, parallel with the North line of said Section Thirty (30), for a distance of 360 feet; thence Westerly, deflecting to the left  $00^{\circ}32'15''$ , for a distance of 1,349.85 feet to a point on the West line of the Northeast Quarter (NE%) of said Section Thirty (30); thence Northerly along the West line of the Northeast Quarter (NE4) of said Section Thirty (30) for a distance of 78.66 feet, more or less, to the place of beginning.

Section 3. FILING. The City Clerk is hereby directed to file copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor of Norman County, and the 'Town Clerk of the Township of Halstad.
