

ORDINANCE NO. 68

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SPICER, A MUNICIPAL CORPORATION OF THE STATE OF MINNESOTA, TO INCLUDE CERTAIN LANDS NOT EXCEEDING 200 ACRES.

WHEREAS, a Petition has been filed with the governing body of the City of Spicer, a municipal corporation of the State of Minnesota, by the property owner having the sole interest therein, to have certain real property hereinafter described included within the limits of the City of Spicer; and

WHEREAS, it is proposed to annex by virtue hereof to said City of Spicer said property all of which said property is in Kandiyohi County, Minnesota; and

WHEREAS, the property to be annexed consists of 5.5 acres more or less described as follows, to-wit:

The East 323 feet of the North 800 feet of the Northwest Quarter of the Northwest Quarter of Section 10, Township 120 North, Range 34 West except the following described tracts that part lying East of the following described line beginning at a point on the north line of the Northwest Quarter of Section 10, Township 120, Range 34 West that is 1,055.3 feet East of the Northwest corner of said section thence South 14°6' West 169.3 feet; thence South 39°24' West 279.4 feet; thence South 12°2' East to the South line of the North 800 feet and there terminating; also excepting that part of the North 660 feet of the East 323 of the North 800 feet lying West of the following line beginning at a point that is 716.5 feet East of the Northwest corner of the Northwest Quarter; thence Southwest and parallel to the center line of Trunk Highway 23, 660 feet to a point that is 567.27 + or - feet East of the West line and 642.43 + or - feet South of the north line of said Section 10, Township 120, Range 34.

NOW THEREFORE, The City Council of the City of Spicer hereby determines, ordains, and declares as follows:

Section 1. That the annexation would be to the best interest of the City of Spicer, Minnesota and to the best interest of the property affected.

Section 2. That the property above described abuts on the City Limits and is so conditioned as property to be subject to city government.

Section 3. That the property is hereby annexed to, and included within, the City of Spicer, Minnesota as effectually as if it had originally been a part hereof.

Section 4. That this ordinance shall be filed and shall take effect and be in full force and effect from and after the filing of a copy of this ordinance with the Minnesota

Municipal Commission, Green Lake Town Clerk, Kandiyohi County Auditor and the Secretary of State of Minnesota, and from and after its passage and publication.
