

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN REAL ESTATE TO THE CITY OF STOCKTON

The City Council, the City of Stockton, Winona County, Minnesota, hereby ordains:

That Daryl Potter and Beverly Lois Potter, his wife, having heretofore submitted to this Council a Petition for Annexation, dated October 16, 1974 for the annexation to said City of lands hereinafter described, owned by Daryl Potter and Beverly Lois Potter, his wife, and adjacent to and abutting upon the limits of the City of Stockton, and that:

1. That Daryl Potter and Beverly Lois Potter, his wife, are the owners of all of the said lands and that said Petition has been executed by said Daryl Potter and Beverly Lois Potter.

2. That said land is unplatted and does not exceed two hundred acres and that copies of said Petition have been filed with the City of Stockton, the Town Board of Hillsdale Township, the Winona County Board, the Minnesota Municipal Commission, and that all of said lands lie within the County of Winona, and the Town of Hillsdale, and abutt upon, or in or adjacent to the boundaries of the City of Stockton.

3. That sixty days have elapsed from the time of filing said Petition and that no objections thereto have been submitted to the City of Stockton.

4. That this Council finds that the annexation of said land is to be in the best interest of the municipality in the territory affected, which territory is described as follows, to-wit:


That part of the Northeast Quarter (NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirty three (33), Township One Hundred Seven (107) North, Range Eight (8), West

of the Fifth Principal Meridian which
lies North and East of County Highway
No. 20, Hillsdale Township Road No. 12.

5. That this ordinance is enacted pursuant to the provisions
of Minnesota Statute Annotated, Section 414.033, and shall become
effective upon the publication thereof and upon the filing with the
Municipal Commission of the State of Minnesota, the County Auditor
of Winona County, the Town Clerk of Hillsdale Township, and the
Secretary of State, State of Minnesota.


