### Ordinance No. 34

An ordinance extending the village of Swanvilla some state, so as to be supported real estate, to-wit: Blocks One, Two and Three together with Streets and Alleys as shown by plot thereof now on Record in the office of the Register of Deeds in and for the County of Morrison and State of Minnesota.

The Village Council of the Village of Swanville do ordain as follows:

# SECTION 1.

That the boundaries of the village of Swanville, Minnesota be, and the same hereby are, extended so as to include a piece or parcel of land, abutting upon said village, known and platted as McRae's addition to Swanville and described as follows, to-wit: Blocks 1, Two and Three together with Street and Alleys as shown by plot therof now on file in the Office of the Register of Deeds in and for the County of Morrison and State of Minnesota.

## SECTION 2.

That said real estate be, and the same hereby is made, to constitute, for all purposes, a part of the said village of Swanville, subject in all respects to the goverment of the said village.

#### SECTION 3.
