

ORDINANCE NO. 41

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF ELBOW LAKE, GRANT COUNTY, MINNESOTA.

BE IT ORDAINED by the City Council of the City of Elbow Lake, Grant County, Minnesota:

SECTION I. That the following described property located in the Township of Sanford, Grant County, Minnesota, is hereby annexed to the City of Elbow Lake, Grant County, Minnesota:

Beginning at the southeast corner of Section Nine (9) Township One Hundred Twenty-nine (129), North, Range Forty-two (42) West, Fifth Principal Meridian, thence in a westerly direction along the south line of said Section Nine (9), a distance of Nine Hundred Fifty-five feet (955') to the point of beginning; thence at right angles and in a northerly direction a distance of Eight (80) rods more or less to the north boundary line of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of said Section Nine (9); thence at right angles and in a westerly direction along the northerly boundary line of said Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of said Section Nine (9), to the northwest corner of said Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of said Section Nine (9); thence at right angles and in a southerly direction along the westerly boundary line of said Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of said Section Nine (9), a distance of Eighty (80) rods more or less to the southerly boundary line of said Section Nine (9); thence in an easterly direction along the southerly boundary line of said Section Nine (9) to the place of beginning. All of the foregoing being a part of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Nine (9), Township One Hundred Twenty-nine (129), Range Forty-two (42).

SECTION II. This Ordinance shall be in force and effect from and after the date of its passage and publication.
