The undersigned petitioner would respectfully represent that he is a citizen of Minneapolis, County of Hennepin, and State of Minnesota; and that there are four (4) Islands in the Basswood Lake, one in Section five (5), one in Section three (3), one in Section Ten (10) and one in Section eleven (11), Township Sixty-four (64), Range Ten (10), State of Minnesota, per plat attached; that said islands have never been surveyed by the United States Government; that he is desirous that the same should be surveyed, in order that they may be disposed of according to the laws of Congress and the regulations of the General Land Office relative to the disposal of lands embraced in fragmentary surveys.

Stanley Coffin and Howard R. Colover, citizens of
the City of Minneapolis, County of Hennepin, State of Minnesota,
being duly sworn, upon their oaths say:

That they have personal knowledge of four (4) certain
islands in Basswood Lake, one in each of Sections Two (2),
Three (3), Ten (10), and Eleven (11), Township Sixty-four (64),
Range Ten (10) West of the Principal Meridian,
in the State of Minnesota, according to a plot of the same hereto
attached, application for the survey of which has been made by
George H. Colover, of the City of Minneapolis, County of Hennepin,
State of Minnesota.

That said island in Section Number Ten (2) contains
about four (4) acres; that the width of the channel between the
said island and the nearest main shore, Section Lot Fourteen (14)
in Section Three (3) is One Hundred Sixty-five (165) paces;
that the distance from said island to the nearest southerly
shore of mainland, being Lot Six (6) in Section Eleven (11) is
approximately Four Thousand (4000) feet; that the depth of the
water at ordinary stages is from twenty (20) to thirty (30)
feet; that said island is about thirty (30) feet above high
water mark, not subject to overflow, and the land fit for
agricultural purposes; that the configuration of either shore
of the mainland has not materially changed since the original
survey of the water front on the mainland, and that there are no

improvements on said island.

That said island in Section Three (3) contains about three (3) acres; that the width of the channel between the island and the nearest main shore, the same being Lot Six (6) in Section Eleven (11), is approximately Three Thousand Three Hundred (3300) feet, and that the depth of the intervening water at ordinary stages of the water is about thirty (30) feet; that said island is about Fifteen (15) feet above high water mark, not subject to overflow, and the island fit for agricultural purposes; that the configuration of either shore of the mainland has not materially changed since the original survey of the water front on the mainland, and that there are no improvements on said island.

That said island in Section Ten (10) contains about six (6) acres; that the width of the channel between said island and the nearest main shore is approximately Five Thousand Two Hundred (5200) feet, and the depth thereof at ordinary stages of water is about forty (40) feet; that said island is about twenty (20) feet above high water mark, not subject to overflow, and the land fit for agricultural purposes; that the configuration of either shore of the mainland has not materially changed since the original survey of the water front on the mainland, and that there are no improvements on said island.

That said island in Section Eleven (11) contains about ten (10) acres; that the width of the channel between the island/the nearest main shore, to-wit: Lot Five (5) of said Section Eleven (11) is about Five Hundred Feet (500), and the depth thereof at ordinary stages of the water is about twenty (20) feet; that said island is about thirty (30) feet above high water mark, not subject to overflow, and the land fit for agricultural purposes; that the configuration of either shore of the main-
