Honorable John F. D. Meighan, Judge of the District Court, presiding,  
at the "Scenic Hotel" in the unincorporated Village of Reno, in said  
County, on the 9th day of June, 1922, at 10 o'clock in the forenoon  
of said day, and the Court pursuant to said hearing made its order  
on the 15th day of June, 1922, establishing said District and appoint-  
ing Otto H. Luttkens, Frank J. Greener and William Brazor as the  
first Board of Directors. It now appears to the Court that the name  
of the Director, William Brazor, was misspelled in said order and  
should be "William Breener" and that the name William Brazor as used  
in said order was intended for "William Breener", and it further ap-  
pearing that the terms of the said members of said Board of Directors  
were not fixed in said motion,

NOW, THEREFORE, ON motion of Luxbury & Luxbury, Attorneys  
for petitioners herein,

IT IS ORDERED, That the said order of the Court herein,  
dated June 15, 1922, be amended by striking out the surname "Brazor"  
wherever the same appears in said order and inserting in the places  
thereof the surname "Breener".

AND IT IS FURTHER ORDERED, That the said William Breener  
shall hold office for a term of two years from the date of the or-  
ganization of said Board, and the said Otto H. Luttkens and Frank  
J. Greener shall each hold office for a term of four years from the  
organization of said Board.

take effect as of the date of the original order, that is June 15,  
1922.
