Clarifying the transfer of functions, positions and appropriations related to the administration of the state employee payroll system from the Department of Administration to the Department of Finance per Laws 1973, Chapter 492, Section 4, Subdivision 2 and 3, Section 5 and Section 13, Subdivision 5 and 6.

Pursuant to Minnesota Statutes, Sections 16.125, 16.13 and 16.135 the following administrative reorganization is hereby made.

Laws 1973, Chapter 492, Section 4, Subdivision 2 and 3, Section 5, and Section 13, Subdivision 5 and 6 transfers powers, duties and responsibilities for payroll administration and appropriations for these purposes from the Department of Administration to the Department of Finance.

The following positions of the Department of Administration, and their incumbents with all accrued benefits, are here by transferred to the Department of Finance.
